Mr. MCNERNEY (for himself, Mr. RANGEL, Mr. BUTTERFIELD, Mr. BEN RAY LUJÁN of New Mexico, Mr. RUSH, Mr. HASTINGS of Florida, and Mr. VALADAO) introduced the following bill; which was referred to the Committee on Energy and Commerce

A BILL

To amend the Public Health Service Act to provide for the establishment of a drug-free workplace information clearinghouse, to support residential methamphetamine treatment programs for pregnant and parenting women, to improve the prevention and treatment of methamphetamine addiction, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Methamphetamine
5 Education, Treatment, and Hope Act of 2013”.

1 **SEC. 2. ENHANCING HEALTH CARE PROVIDER AWARENESS**
2 **OF METHAMPHETAMINE ADDICTION.**

3 Section 507(b) of the Public Health Service Act (42
4 U.S.C. 290bb(b)) is amended—

5 (1) by redesignating paragraphs (13) and (14)
6 as paragraphs (14) and (15), respectively; and

7 (2) by inserting after paragraph (12) the fol-
8 lowing:

9 “(13) collaborate with professionals in the ad-
10 diction field and primary health care providers to
11 raise awareness about how to—

12 “(A) recognize the signs of a substance
13 abuse disorder; and

14 “(B) apply evidence-based practices for
15 screening and treating individuals with or at-
16 risk for developing an addiction, including ad-
17 diction to methamphetamine or other drugs;”.

18 **SEC. 3. RESIDENTIAL TREATMENT PROGRAMS FOR PREG-**
19 **NANT AND PARENTING WOMEN.**

20 Section 508 of the Public Health Service Act (42
21 U.S.C. 290bb-1) is amended—

22 (1) in subsection (a)—

23 (A) in the matter preceding paragraph (1),
24 by striking “postpartum women treatment for
25 substance abuse” and inserting “parenting
26 women treatment for substance abuse (includ-

1 ing treatment for addiction to methamphet-
2 amine)”;

3 (B) in paragraph (1), by striking “reside
4 in” and inserting “reside in or receive out-
5 patient treatment services from”; and

6 (C) in paragraph (2), by striking “the
7 minor children of the women reside with the
8 women in such facilities” and inserting “the
9 minor children of the women who reside in such
10 facilities reside with such women”;

11 (2) in subsection (d), by amending paragraph
12 (2) to read as follows:

13 “(2) Referrals for necessary hospital and dental
14 services.”;

15 (3) by amending subsection (m) to read as fol-
16 lows:

17 “(m) ALLOCATION OF AWARDS.—In making awards
18 under subsection (a), the Director shall give priority to
19 any entity that agrees to use the award for a program
20 serving an area that—

21 “(1) is a rural area, an area designated under
22 section 332 by the Administrator of the Health Re-
23 sources and Services Administration as a health pro-
24 fessional shortage area with a shortage of mental
25 health professionals, or an area determined by the

1 Director to have a shortage of family-based sub-
2 stance abuse treatment options; and

3 “(2) is determined by the Director to have high
4 rates of addiction to methamphetamine or other
5 drugs.”;

6 (4) in subsection (p)—

7 (A) by striking “October 1, 1994” and in-
8 serting “one year after the date of the enact-
9 ment of the Methamphetamine Education,
10 Treatment, and Hope Act of 2013”;

11 (B) by inserting “In submitting reports
12 under this subsection, the Director may use
13 data collected under this section or other provi-
14 sions of law, insofar as such data is used in a
15 manner consistent with all Federal privacy laws
16 applicable to the use of data collected under
17 this section or other provision, respectively.”
18 after “biennial report under section 501(k).”;
19 and

20 (C) by striking “Each report under this
21 subsection shall include” and all that follows
22 and inserting “Each report under this sub-
23 section shall, with respect to the period for
24 which the report is prepared, include the fol-
25 lowing:

1 “(1) A summary of any evaluations conducted
2 under subsection (o).

3 “(2) Data on the number of pregnant and par-
4 enting women in need of, but not receiving, treat-
5 ment for substance abuse. Such data shall include,
6 but not be limited to, the number of pregnant and
7 parenting women in need of, but not receiving, treat-
8 ment for methamphetamine abuse, disaggregated by
9 State and tribe.

10 “(3) Data on recovery and relapse rates of
11 women receiving treatment for substance abuse
12 under programs carried out pursuant to this section,
13 including data disaggregated with respect to treat-
14 ment for methamphetamine abuse.”;

15 (5) by redesignating subsections (q) and (r) as
16 subsections (r) and (s), respectively;

17 (6) by inserting after subsection (p) the fol-
18 lowing:

19 “(q) METHAMPHETAMINE ADDICTION.—In carrying
20 out this section, the Director shall expand, intensify, and
21 coordinate efforts to provide pregnant and parenting
22 women treatment for addiction to methamphetamine or
23 other drugs.”; and

24 (7) in subsection (s) (as so redesignated), by
25 striking “such sums as may be necessary to fiscal

1 years 2001 through 2003” and inserting
2 “\$16,000,000 for fiscal year 2014, \$16,500,000 for
3 fiscal year 2015, \$17,000,000 for fiscal year 2016,
4 \$17,500,000 for fiscal year 2017, and \$18,000,000
5 for fiscal year 2018”.

6 **SEC. 4. WORKPLACE INFORMATION CLEARINGHOUSE.**

7 Section 515(b) of the Public Health Service Act (42
8 U.S.C. 290bb–21(b)) is amended—

9 (1) in paragraph (10), by striking “and” at the
10 end;

11 (2) by redesignating paragraph (11) as para-
12 graph (13); and

13 (3) by inserting after paragraph (10) the fol-
14 lowing new paragraph:

15 “(11) maintain a clearinghouse that provides
16 information and educational materials to employers
17 and employees about comprehensive drug-free work-
18 place programs and substance abuse prevention and
19 treatment resources;”.

20 **SEC. 5. YOUTH INVOLVEMENT IN PREVENTION STRATE-**
21 **GIES.**

22 Section 515(b) of the Public Health Service Act (42
23 U.S.C. 290bb–21(b)), as amended by section 4, is further
24 amended by inserting after paragraph (11) the following
25 new paragraph:

1 “(12) support the involvement of youth in the
2 development and implementation of prevention strat-
3 egies focused on youth, with regard to methamphet-
4 amine and other drugs; and”.
