- To amend title 38, United States Code, to prohibit the imposition or collection of copayments for certain mental health outpatient care visits of veterans, and for other purposes.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "Reduce and Eliminate
- 3 Mental Health Outpatient Veteran Copays Act" or the
- 4 "REMOVE Copays Act".
- 5 SEC. 2. PROHIBITION ON COLLECTION OF COPAYMENTS
- 6 FOR FIRST THREE MENTAL HEALTH CARE
- 7 OUTPATIENT VISITS OF VETERANS.
- 8 (a) Prohibition on Collection.—Chapter 17 of
- 9 title 38, United States Code, is amended by inserting after
- 10 section 1722B the following new section (and conforming
- 11 the table of sections at the beginning of such chapter ac-
- 12 cordingly):
- 13 "§ 1722C. Copayments: prohibition on collection of
- copayments for first three mental health
- care outpatient visits of veterans
- 16 "(a) Prohibition.—Except as provided in sub-
- 17 section (b), notwithstanding section 1710(g) of this title
- 18 or any other provision of law, the Secretary may not im-
- 19 pose or collect a copayment for the first three mental
- 20 health care outpatient visits of a veteran in a calendar
- 21 year for which the veteran would otherwise be required
- 22 to pay a copayment under the laws administered by the
- 23 Secretary.
- 24 "(b) Copayment for Medications.—The prohibi-
- 25 tion under subsection (a) shall not apply with respect to

- 1 the imposition or collection of copayments for medications
- 2 pursuant to section 1722A of this title.
- 3 "(c) Mental Health Care Outpatient Visit De-
- 4 FINED.—In this section, the term 'mental health care out-
- 5 patient visit' means an outpatient visit with a qualified
- 6 mental health professional for the primary purpose of
- 7 seeking mental health care or treatment for substance
- 8 abuse disorder.".
- 9 (b) APPLICABILITY.—The amendments made by sub-
- 10 section (a) shall apply with respect to mental health care
- 11 outpatient visits occurring on or after the date that is 180
- 12 days after the date of the enactment of this Act.
