1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “National Park Founda-
5 tion Reauthorization Act of 2022”.

6 **SEC. 2. AUTHORIZATION OF APPROPRIATIONS FOR THE NA-**
7 **TIONAL PARK FOUNDATION.**

8 Section 101122(a) of title 54, United States Code,
9 is amended—

- 10 (1) by striking “\$5,000,000” and inserting
11 “\$15,000,000”; and
12 (2) by striking “2023” and inserting “2030”.
