## A BILL

To direct the Secretary of Education to establish a competitive grant program to award grants to local educational agencies to address implicit bias in elementary and secondary schools, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2        *tives of the United States of America in Congress assembled,*

3        **SECTION 1. SHORT TITLE.**

4        This Act may be cited as the “Combating Implicit  
5        Bias in Education Act”.

6        **SEC. 2. GRANT PROGRAM.**

7        (a) **ESTABLISHMENT.**—The Secretary of Education  
8        shall award grants, on a competitive basis, to local edu-

1 cational agencies to provide training to educators, prin-  
2 cipals, and other staff of elementary schools and secondary  
3 schools on implicit bias, for the purposes of—

4 (1) ending discrimination based on such bias,  
5 including—

6 (A) in the administration of exclusionary  
7 discipline (including suspensions and expul-  
8 sions);

9 (B) in access to gifted and talented pro-  
10 grams; and

11 (C) in the apportionment of academic re-  
12 sources;

13 (2) improving the school climate and the rela-  
14 tionships between students and educators, principals,  
15 and other staff; and

16 (3) improving the academic achievement and at-  
17 tainment of students.

18 (b) APPLICATION.—A local educational agency desir-  
19 ing to receive a grant under this section shall submit an  
20 application to the Secretary as the Secretary shall require.  
21 The application shall include a description of how the local  
22 educational agency will use the grant to carry out training  
23 under subsection (a).

1 (c) REPORT.—The Director of the Institute of Edu-  
2 cation Sciences shall conduct a periodic review of the effec-  
3 tiveness of the grant program established by this Act.

4 (d) AUTHORIZATION OF APPROPRIATIONS.—For the  
5 purpose of carrying out this Act, there are authorized to  
6 be appropriated \$10,000,000 for each of fiscal years 2025  
7 through 2027.

8 (e) DEFINITIONS.—In this Act:

9 (1) ELEMENTARY AND SECONDARY EDUCATION  
10 ACT TERMS.—The terms “elementary school”, “local  
11 educational agency”, “other staff”, and “secondary  
12 school” have the meanings given those terms in sec-  
13 tion 8101 of the Elementary and Secondary Edu-  
14 cation Act of 1965 (20 U.S.C. 7801).

15 (2) IMPLICIT BIAS.—The term “implicit bias”  
16 means bias with respect to actual or perceived race,  
17 religion, sex (including sexual orientation or gender  
18 identity), disability, ethnicity, or socioeconomic sta-  
19 tus that results from subconsciously held attitudes,  
20 beliefs, or associations.

21 (3) TRAINING.—The term “training” means  
22 evidence-based, on-going professional development  
23 and support.
