# **A BILL**

To authorize the Secretary of the Interior to issue a right-of-way permit with respect to a natural gas distribution pipeline within Valley Forge National Historical Park, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        *This Act may be cited as the “Valley Forge Park Re-*  
5 *alignment Permit and Promise Act”.*

6 **SEC. 2. RIGHT-OF-WAY PERMIT FOR NATURAL GAS DIS-**  
7                    **TRIBUTION MAIN SEGMENT AT VALLEY**  
8                    **FORGE NHP.**

9        (a) *IN GENERAL.*—*Notwithstanding any other provi-*  
10 *sion of law, the Secretary may issue a right-of-way permit*  
11 *pursuant to part 14 of title 36, Code of Federal Regulations*  
12 *(as in effect on the date of the enactment of this Act), for*  
13 *the covered main segment if the covered main segment is*  
14 *relocated to a proposed realignment of Valley Forge Park*  
15 *Road and North Gulph Road within the Park.*

16        (b) *SCOPE OF AUTHORITY.*—*The authority to grant a*  
17 *right-of-way permit under subsection (a) shall apply only*  
18 *to the covered main segment and shall not apply to any*  
19 *other part of the natural gas distribution main system or*  
20 *any other pipeline system within the Park.*

21        (c) *DEFINITIONS.*—*In this section:*

22                    (1) *COVERED MAIN SEGMENT.*—*The term “cov-*  
23 *ered main segment” means the portions of the natural*  
24 *gas distribution main (including all appurtenances*

1       *used in the operation of such main) within the*  
2       *Park—*

3               *(A) existing on the date of the enactment of*  
4       *this Act; and*

5               *(B) that are located under, along, or adja-*  
6       *cent to the segments of North Gulph Road and*  
7       *Valley Forge Park Road (SR3039 and SR0023*  
8       *respectively, as those roads were aligned on Jan-*  
9       *uary 21, 2022) that are between—*

10               *(i) the intersection of North Gulph*  
11       *Road with Richards Road; and*

12               *(ii) a point on Valley Forge Park*  
13       *Road located 500 feet northwest of its inter-*  
14       *section with County Line Road.*

15       (2) *PARK.—The term “Park” means Valley*  
16       *Forge National Historical Park.*

17       (3) *SECRETARY.—The term “Secretary” means*  
18       *the Secretary of the Interior.*
