A BILL

To amend the Public Health Service Act to prohibit the Director of the National Institutes of Health from conducting or funding research that causes significant pain or distress to a dog or cat, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the “Preventing Animal
5 Abuse and Waste Act” or the “PAAW Act”.

6 SEC. 2. FINDINGS.

7 Congress finds the following:

1 (1) The National Institutes of Health (in this
2 section referred to as “NIH”) spends taxpayer dol-
3 lars to conduct and fund research that causes pain
4 and distress to dogs and cats.

5 (2) The NIH states that “animal models often
6 fail to provide good ways to mimic disease or predict
7 how drugs will work in humans, resulting in much
8 wasted time and money while patients wait for
9 therapies”.

10 (3) The NIH often conducts and funds tests on
11 dogs to assess the safety of experimental human
12 drugs even though the Food and Drug Administra-
13 tion has stated, “The FDA does not mandate that
14 human drugs be studied in dogs.”.

15 (4) The National Academies of Sciences, Engi-
16 neering, and Medicine has repeatedly found research
17 on dogs, cats, and other animals that is conducted
18 and funded by the NIH and other agencies to be un-
19 necessary.

20 (5) Alternative research methodologies and
21 other species can replace the use of dogs and cats
22 in NIH-conducted and funded research.

23 (6) Federal agencies including the Department
24 of Veterans Affairs, the Environmental Protection
25 Agency, and the Food and Drug Administration

1 have launched initiatives to reduce and replace test-
2 ing on dogs and cats, specifically.

3 (7) Existing reporting mechanisms do not pro-
4 vide adequate information to Congress and tax-
5 payers about the scale, scope, and cost of dog and
6 cat use in NIH-conducted and funded research.

7 **SEC. 3. PROHIBITION ON RESEARCH CAUSING SIGNIFICANT**
8 **PAIN OR DISTRESS TO DOGS AND CATS.**

9 (a) IN GENERAL.—Subpart 6 of part C of title IV
10 of the Public Health Service Act (42 U.S.C. 285f et seq.)
11 is amended by adding at the end the following:

12 **“SEC. 447E. PROHIBITION ON RESEARCH CAUSING SIGNIFI-**
13 **CANT PAIN OR DISTRESS TO DOGS AND CATS.**

14 “(a) IN GENERAL.—The Director of NIH may not
15 conduct or support any research that causes significant
16 pain or distress to a dog or cat.

17 “(b) DEFINITION.—In this section, the term ‘re-
18 search that causes significant pain or distress’ includes
19 any study classified in pain category D or E by the De-
20 partment of Agriculture.”.

21 (b) APPLICABILITY.—The amendment made by sub-
22 section (a) applies beginning on the date that is 90 days
23 after the date of enactment of this Act.

1 **SEC. 4. REPORTING.**

2 (a) NIH REPORT ON RESEARCH CAUSING PAIN OR

3 DISTRESS TO DOGS AND CATS.—

4 (1) IN GENERAL.—Not later than 6 months
5 after the date of enactment of this Act, and annually
6 thereafter, the Director of the NIH shall publish on
7 the NIH website, and submit to the Committee on
8 Energy and Commerce of the House of Representa-
9 tives and to the Committee on Health, Education,
10 Labor, and Pensions of the Senate, a report on the
11 use of dogs and cats in NIH-conducted and funded
12 biomedical research.

13 (2) CONTENTS OF REPORT.—Each report under
14 paragraph (1) shall include, for the period covered
15 by the report—

16 (A) a list of all ongoing or prospective re-
17 search projects that cause significant pain or
18 distress to a dog or cat and are conducted or
19 funded by the NIH;

20 (B) for each project—

21 (i) the project title;

22 (ii) the grant or contract number;

23 (iii) the research abstract;

24 (iv) the research location;

25 (v) the cost to taxpayers during the
26 previous fiscal year and since inception;

- (vi) the number of dogs or cats used;
- (vii) the projected start and end dates;

(viii) the Department of Agriculture pain and distress category; and

(ix) the amount of funds obligated or estimated to be obligated for each such project;

(C) an explanation of—

(i) efforts to phase out the use of dogs and cats in research that is conducted or funded by the NIH; and

(ii) any barriers to such phase out; and

(D) the number of dogs and cats retired adopted from research conducted or funded by the NIH.

18 (b) GAO STUDY ON NIH DOG AND CAT RESEARCH
19 AND EFFORTS TO REDUCE USE OF DOGS AND CATS IN
20 TESTING.—Not later than one year after the date of en-
21 actment of this Act, the Comptroller General of the United
22 States shall submit a report to the Congress that—

23 (1) reviews and summarizes the use of dogs and
24 cats in research that is conducted or funded by the
25 NIH;

1 (2) identifies NIH policies and initiatives aimed
2 at reducing and replacing the specific use of dogs
3 and cats in research that causes significant pain or
4 distress and is conducted or funded by the NIH;

5 (3) assesses the effectiveness of any NIH poli-
6 cies and initiatives aimed at reducing and replacing
7 the use of dogs and cats in NIH-conducted and
8 funded research;

9 (4) compares NIH efforts to reduce and replace
10 dog and cat testing to similar efforts at other Fed-
11 eral agencies;

12 (5) identifies areas where the NIH can im-
13 prove—

14 (A) efforts to reduce and replace the use of
15 dogs and cats in research that is conducted or
16 funded by the NIH; and

17 (B) public reporting on progress made;

18 (6) assesses the effectiveness of any NIH poli-
19 cies and initiatives aimed at retiring and re-homing
20 dogs and cats no longer needed in research con-
21 ducted or funded by the NIH;

22 (7) makes recommendations for improving—

23 (A) the effectiveness of efforts to reduce
24 and replace the use of dogs and cats in research
25 conducted or funded by the NIH; and

1 (B) public reporting on progress made;

2 and

(8) includes any other matter the Comptroller General of the United States determines important to assessing and improving NIH's efforts to reduce and replace the use of dogs and cats in federally funded research that causes significant pain or distress.

9 (c) DEFINITION.—In this section:

10 (1) The term “NIH” means the National Insti-
11 tutes of Health.
