Mr. CURTIS (for himself and Mr. JOYCE of Pennsylvania) introduced the
following bill; which was referred to the Committee on Ways and Means

A BILL

To prohibit payment of Pandemic Unemployment Assistance
and Federal Pandemic Unemployment Compensation to
millionaires.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Returning Inappro-
5 priate Cash Handouts Act” or the “RICH Act”.

1 **SEC. 2. PROHIBITING PAYMENT OF PANDEMIC UNEMPLOY-**
2 **MENT ASSISTANCE AND FEDERAL PANDEMIC**
3 **UNEMPLOYMENT COMPENSATION TO MIL-**
4 **LIONAIRES.**

5 (a) PANDEMIC UNEMPLOYMENT ASSISTANCE.—Sec-
6 tion 2102 of the Relief for Workers Affected by
7 Coronavirus Act (contained in subtitle A of title II of divi-
8 sion A of the CARES Act (Public Law 116–136)) is
9 amended—

10 (1) in subsection (a)(3)(B)—

11 (A) in clause (i), by striking “or” at the
12 end;

13 (B) in clause (ii), by striking the period at
14 the end and inserting “; or”; and

15 (C) by adding at the end the following new
16 clause:

17 “(iii) an individual whose adjusted
18 gross income is equal to or greater than
19 \$1,000,000.”; and

20 (2) by adding at the end the following new sub-
21 section:

22 “(i) PROHIBITION ON ASSISTANCE TO MILLION-
23 AIRES.—

24 “(1) COMPLIANCE.—Any application for assist-
25 ance authorized under subsection (b) shall include a
26 form or procedure for an individual applicant to cer-

1 tify that such individual is not prohibited from re-
2 ceiving such assistance pursuant to subsection
3 (a)(3)(B)(iii).

4 “(2) AUDITS.—The certifications required by
5 paragraph (1) shall be auditable by the Department
6 of Labor or the Government Accountability Office.”.

7 (b) FEDERAL PANDEMIC UNEMPLOYMENT COM-
8 PENSATION.—Section 2104(b) of the Relief for Workers
9 Affected by Coronavirus Act (contained in subtitle A of
10 title II of division A of the CARES Act (Public Law 116-
11 136)) is amended by adding at the end the following new
12 paragraph:

13 “(3) PROHIBITION ON COMPENSATION TO MIL-
14 LIONAIRES.—

15 “(A) IN GENERAL.—Federal Pandemic
16 Unemployment Compensation shall not be pay-
17 able to any individual whose adjusted gross in-
18 come is equal to or greater than \$1,000,000.

19 “(B) COMPLIANCE.—Any application for
20 regular compensation shall include a form or
21 procedure for an individual applicant to certify
22 that such individual is not prohibited from re-
23 ceiving Federal Pandemic Unemployment Com-
24 pensation pursuant to subparagraph (A).

1 “(C) AUDITS.—The certifications required
2 by subparagraph (B) shall be auditable by the
3 Department of Labor or the Government Ac-
4 countability Office.”.

5 (c) RULE OF CONSTRUCTION.—Nothing in this Act,
6 or any amendment made by this Act, may be construed
7 to apply to regular compensation or extended compensa-
8 tion (as such terms are defined by section 205 of the Fed-
9 eral-State Extended Unemployment Compensation Act
10 (26 U.S.C. 3304 note)) to which an individual may be oth-
11 erwise entitled.

12 (d) EFFECTIVE DATE.—The amendments made by
13 this section shall apply to weeks of unemployment begin-
14 ning on or after the date of the enactment of this Act.
