A BILL

To designate certain organizations as foreign terrorist organizations.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Iranian Terror Preven-
3 tion Act”.

4 **SEC. 2. DESIGNATION AS FTO; IMPOSITION OF SANCTIONS.**

5 (a) DESIGNATION AS FTO.—Not later than 90 days
6 after the date of the enactment of this Act, the Secretary
7 of State shall designate as a foreign terrorist organization
8 pursuant to section 219(a) of the Immigration and Na-
9 tionality Act (8 U.S.C. 1189(a)) each of the following:

10 (1) Abu Fadl al-Abbas Brigades.

11 (2) Ansarallah (otherwise known as the
12 “Houthis”).

13 (3) Badr Organization.

14 (4) Fatemiyoun Brigade.

15 (5) Harakat Hezbollah al-Nujaba.

16 (6) Kata’ib al-Imam Ali.

17 (7) Kata’ib Jund al-Imam.

18 (8) Kata’ib Sayyad al Shuhada.

19 (9) Sarayya al-Jihad.

20 (10) Sarayya Khorasani.

21 (11) Zainabiyoun Brigade.

22 (12) Any foreign entity or organization that is
23 an agent of, affiliated with, or owned or controlled
24 by the Islamic Revolutionary Guard Corps.

25 (b) IMPOSITION OF SANCTIONS.—

1 (1) IN GENERAL.—Not later than 60 days after
2 the date of the enactment of this Act, the President
3 shall determine whether to impose the sanctions de-
4 scribed in paragraph (3) on any organization listed
5 under paragraph (2) or any entity or organization
6 that is an agent, affiliate, or instrumentality, or
7 owned or controlled by an agent, affiliate, or instru-
8 mentality of an organization listed in paragraph (2).

9 (2) ORGANIZATIONS.—The following are organi-
10 zations with respect to which a sanction determina-
11 tion shall be made:

- 12 (A) Abu Fadl al-Abbas Brigades.
- 13 (B) Badr Organization.
- 14 (C) Kata'ib al-Imam Ali.
- 15 (D) Kata'ib Jund al-Imam.
- 16 (E) Sarayya al-Jihad.
- 17 (F) Sarayya Khorasani.

18 (3) SANCTIONS DESCRIBED.—The sanctions de-
19 scribed in this subsection are sanctions applicable
20 with respect to a foreign person pursuant to Execu-
21 tive Order 13224 (50 U.S.C. 1701 note; relating to
22 blocking property and prohibiting transactions with
23 persons who commit, threaten to commit, or support
24 terrorism).

25 (c) REPORT.—

1 (1) SECRETARY OF STATE REPORT.—Not later
2 than 180 days after the date of enactment of this
3 Act, and every 180 days thereafter, the Secretary of
4 State, in consultation with the Secretary of Com-
5 merce, shall submit to Congress a report on any new
6 entities meeting the requirements for—

7 (A) designation as a foreign terrorist orga-
8 nization; or

9 (B) imposition of sanctions with respect to
10 a foreign person pursuant to Executive Order
11 13224 (50 U.S.C. 1701 note; relating to block-
12 ing property and prohibiting transactions with
13 persons who commit, threaten to commit, or
14 support terrorism).

15 (2) PRESIDENTIAL REPORT.—The President
16 shall submit to Congress a report not later than 60
17 days after a determination has been made under
18 subsection (b) on whether the organizations listed
19 under such subsection have sanctions imposed pur-
20 suant to Executive Order 13224 and shall provide a
21 detailed explanation should any such organization
22 not be sanctioned.
