## A BILL

To direct the Secretary of Homeland Security to submit to Congress a report on the security and resilience of the United States medical supply chains, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Strengthening our  
5 Health Security Through Resilient Medical Supply Chains  
6 Annual Review Act of 2020”.

1 **SEC. 2. REPORT ON SECURITY AND RESILIENCE OF THE**  
2 **UNITED STATES MEDICAL SUPPLY CHAINS.**

3 (a) IN GENERAL.—Not later than one year after the  
4 date of the enactment of this Act, and annually thereafter,  
5 the Secretary of Homeland Security shall submit to the  
6 Committee on Homeland Security of the House of Rep-  
7 resentatives, and the Committee on Homeland Security  
8 and Government Affairs of the Senate a report on the se-  
9 curity and resilience of the United States medical supply  
10 chains. Such a report shall contain a classified annex. The  
11 Secretary shall make publicly available (including by publi-  
12 cation on the website of the Department of Homeland Se-  
13 curity) the unclassified portion of the report.

14 (b) CONTENTS.—The report submitted under sub-  
15 section (a) shall—

16 (1) review the United States supply chains for  
17 medical devices, supplies, and drugs and the vulner-  
18 ability of such supply chains to a global disruption,  
19 such as an instance of bioterrorism, a natural dis-  
20 aster, or a public health emergency;

21 (2) assess the dependence of the United States  
22 on any medical devices, equipment, supplies, coun-  
23 termeasures, vaccines, and drugs produced or  
24 sourced outside the United States; and

25 (3) identify the actions the Federal government  
26 has taken during the year covered by the report—

1 (A) to promote the security and resilience  
2 of the United States medical supply chain;

3 (B) to improve medical supply chain re-  
4 dundancy;

5 (C) to encourage the domestic production  
6 of medical devices, equipment, supplies, coun-  
7 termeasures, vaccines, and drugs; and

8 (D) to develop contingency plans for poten-  
9 tial global disruptions; and

10 (4) provide recommendations to agencies of the  
11 Federal Government, States, local, tribal, and terri-  
12 torial governments, and the private sector on ways  
13 to strengthen the security and resilience of the  
14 United States medical supply chain.

15 (c) CONSULTATION.—In preparing the report under  
16 subsection (a), the Secretary of Homeland Security—

17 (1) shall consult with the heads of other rel-  
18 evant Federal agencies; and

19 (2) may consult with public health experts,  
20 health security experts, supply chain experts, and  
21 other individuals with relevant experience.
