A BILL

To require a report by the Attorney General on the impact the border crisis is having on law enforcement at the Federal, State, local, and Tribal level.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Police Our Border Act”.*

5 **SEC. 2. FINDINGS.**

6 *Congress finds as follows:*

7 *(1) Our Federal, State, local, and Tribal law en-*
8 *forcement officers put their lives on the line each day*
9 *in order to protect our country and serve their com-*
10 *munities.*

11 *(2) According to the National Law Enforcement*
12 *Officer Memorial Fund, 136 law enforcement officers*
13 *died in the line-of-duty in 2023.*

14 *(3) Congress should do everything in its power to*
15 *support law enforcement officers at every level and in*
16 *every part of our nation.*

17 *(4) The southwest border crisis created by the*
18 *Biden Administration has made every state a border*
19 *state.*

20 *(5) The Biden border crisis has placed a burden*
21 *on law enforcement agencies across the nation and*
22 *has placed a significant strain on the resources that*
23 *are critical to keeping communities safe.*

1 (6) Law enforcement officers in every state are
2 put in life-threatening scenarios as a direct result of
3 the open borders.

4 (7) Law enforcement has been forced to deal with
5 the influx of fentanyl and many officers are exposed
6 to the drug while on duty.

7 (8) It is in the best interest of law enforcement
8 officers and the communities they serve for Congress
9 to pass, and the President to sign into law, strong
10 border security legislation.

11 **SEC. 3. REPORT.**

12 Not later than 180 days after the date of enactment
13 of this Act, the Attorney General shall submit to Congress
14 a report on the impact the Biden border crisis is having
15 on law enforcement officers at the Federal, State, local, and
16 Tribal level, including—

17 (1) the estimated dollar amount of all resources
18 devoted to addressing the Biden border crisis, and the
19 extent to which such resources are not available to
20 law enforcement agencies;

21 (2) the exposure of law enforcement officers to
22 fentanyl resulting from encounters with illegal aliens
23 at the border and in the United States;

- 1 (3) injuries to law enforcement officers based on
- 2 a connection to the Biden border crisis or exposure to
- 3 fentanyl; and
- 4 (4) the morale of law enforcement officers.
