Mr. SCOTT of Virginia (for himself, Mr. CHABOT, Ms. JACKSON LEE, and Mr. EMMER) introduced the following bill; which was referred to the Committee on the Judiciary

## A BILL

To reauthorize the Justice and Mental Health Collaboration  
Program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Justice and Mental  
5 Health Collaboration Reauthorization Act of 2022”.

6 **SEC. 2. REAUTHORIZATION OF THE JUSTICE AND MENTAL**  
7 **HEALTH COLLABORATION PROGRAM.**

8 (a) IN GENERAL.—Section 2991(b)(5) of title I of  
9 the Omnibus Crime Control and Safe Streets Act of 1968  
10 (34 U.S.C. 10651(b)(5)) is amended—

1 (1) in subparagraph (I)—

2 (A) in clause (i), by striking “teams and  
3 treatment accountability services for commu-  
4 nities” and inserting “teams, treatment ac-  
5 countability services for communities, and train-  
6 ing for State and local prosecutors relating to  
7 diversion programming and implementation”;

8 (B) in clause (v)—

9 (i) in subclause (III), by striking  
10 “and” at the end;

11 (ii) in subclause (IV), by striking the  
12 period at the end and inserting “; and”;  
13 and

14 (iii) by adding at the end the fol-  
15 lowing:

16 “(V) coordinate, implement, and  
17 administer models to address mental  
18 health calls that include specially  
19 trained officers and mental health cri-  
20 sis workers responding to those calls  
21 together.”; and

22 (C) by adding at the end the following:

23 “(vi) SUICIDE PREVENTION SERV-  
24 ICES.—Funds may be used to develop, pro-  
25 mote, and implement comprehensive sui-

1            cide prevention programs and services for  
2            incarcerated individuals that include ongoing  
3            risk assessment.

4            “(vii) CASE MANAGEMENT SERVICES.—Funds may be used for case management  
5            services for preliminary qualified  
6            offenders and individuals who are released  
7            from any penal or correctional institution  
8            to—  
9

10            “(I) reduce recidivism; and

11            “(II) assist those individuals with  
12            reentry into the community.

13            “(viii) ENHANCING COMMUNITY CAPACITY AND LINKS TO MENTAL HEALTH  
14            CARE.—Funds may be used to support, administer, or develop treatment capacity  
15            and increase access to mental health care  
16            and substance use disorder services for  
17            preliminary qualified offenders and individuals  
18            who are released from any penal or  
19            correctional institution.  
20

21            “(ix) IMPLEMENTING 988.—Funds  
22            may be used to support the efforts of State  
23            and local governments to implement and  
24            expand the integration of the 988 universal  
25

1 telephone number designated for the pur-  
2 pose of the national suicide prevention and  
3 mental health crisis hotline system under  
4 section 251(e)(4) of the Communications  
5 Act of 1934 (47 U.S.C. 251(e)(4)), includ-  
6 ing by hiring staff to support the imple-  
7 mentation and expansion.”; and

8 (2) by adding at the end the following:

9 “(K) TEAMS ADDRESSING MENTAL  
10 HEALTH CALLS.—With respect to a multidisci-  
11 plinary team described in subparagraph (I)(v)  
12 that receives funds from a grant under this sec-  
13 tion, the multidisciplinary team—

14 “(i) shall, to the extent practicable,  
15 provide response capability 24 hours each  
16 day and 7 days each week to respond to  
17 crisis or mental health calls; and

18 “(ii) may place a part of the team in  
19 a 911 call center to facilitate the timely re-  
20 sponse to mental health crises.”.

21 (b) AUTHORIZATION OF APPROPRIATIONS.—Section  
22 2991(o)(1)(C) of title I of the Omnibus Crime Control and  
23 Safe Streets Act of 1968 (34 U.S.C. 10651(o)(1)(C)) is  
24 amended by striking “2017 through 2021” and inserting  
25 “2022 through 2026”.

1 **SEC. 3. EXAMINATION AND REPORT ON PREVALENCE OF**  
2 **MENTALLY ILL OFFENDERS.**

3 Section 5(d) of the Mentally Ill Offender Treatment  
4 and Crime Reduction Reauthorization and Improvement  
5 Act of 2008 (Public Law 110–416; 122 Stat. 4355) is  
6 amended by striking “2009” and inserting “each of fiscal  
7 years 2022 through 2026”.
