## A BILL

To require States to obtain information from Social Security Administration on deaths for purposes of voter registration list maintenance, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “You Must Be Alive  
5 To Vote Act of 2021”.

1 **SEC. 2. REQUIRING STATES TO OBTAIN INFORMATION**  
2 **FROM SOCIAL SECURITY ADMINISTRATION**  
3 **ON DEATHS FOR PURPOSES OF VOTER REG-**  
4 **ISTRATION LIST MAINTENANCE.**

5 (a) IN GENERAL.—Section 8(a)(4)(A) of the Na-  
6 tional Voter Registration Act of 1993 (52 U.S.C.  
7 20507(a)(4)(A)) is amended to read as follows:

8 “(A) the death of the registrant, as deter-  
9 mined on the basis of information obtained  
10 through records of the State and of information  
11 obtained through ongoing consultation with the  
12 Social Security Administration; or”.

13 (b) AUTHORITY TO MATCH DATA.—Section 205(r)  
14 of the Social Security Act (42 U.S.C. 405(r)) is amended  
15 by adding at the end the following:

16 “(10) The Commissioner of Social Security shall,  
17 upon the request of a State pursuant to section 8(a)(4)(A)  
18 of the National Voter Registration Act of 1993—

19 “(A) enter into an agreement with the State for  
20 the purpose of matching data in the records of the  
21 Social Security Administration and the official list of  
22 eligible voters of the State; and

23 “(B) include in such agreement safeguards to  
24 assure the maintenance of the confidentiality of any  
25 information disclosed.”.

26 (c) ANNUAL CERTIFICATION; ENFORCEMENT.—

1           (1) CERTIFICATION.—Each State shall certify,  
2           with respect to each calendar year, to the Secretary  
3           of Education and the Secretary of Transportation  
4           that the State has in place an agreement with the  
5           Social Security Administration to share death infor-  
6           mation for purposes of section 8(a)(4)(A) of the Na-  
7           tional Voter Registration Act of 1993.

8           (2) PENALTIES FOR NONCOMPLIANCE.—With  
9           respect to any calendar year in which a State has  
10          failed to so certify, the Secretaries of Education and  
11          Transportation may not make available any Federal  
12          funds to the State, any county within the State, or  
13          any resident of the State.

14          (d) DEFINITIONS.—In this section—

15                 (1) the term “State” means a State of the  
16                 United States and the District of Columbia; and

17                 (2) the term “county” means a parish in Lou-  
18                 isiana, a borough in Alaska, or a county in the other  
19                 48 States.

20          (e) EFFECTIVE DATE.—The amendments made by  
21          this section shall take effect 1 year after the date of enact-  
22          ment of this Act.
