A BILL

To prohibit the implementation of the proposed rule entitled
“Nondiscrimination in Health Programs and Activities”.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Taxpayers Support
5 Life Act”.

1 **SEC. 2. PROHIBITING IMPLEMENTATION OF PROPOSED**
2 **RULE ENTITLED “NONDISCRIMINATION IN**
3 **HEALTH PROGRAMS AND ACTIVITIES”.**

4 (a) IN GENERAL.—The Secretary of Health and
5 Human Services may not finalize, implement, administer,
6 or enforce the proposed rule entitled “Nondiscrimination
7 in Health Programs and Activities” (RIN: 0945–AA17).

8 (b) LIMITATIONS ON FUNDING.—No Federal funds
9 may be used—

10 (1) to finalize, implement, administer, or en-
11 force the proposed rule described in subsection (a);
12 or

13 (2) in contravention of administering or enfore-
14 ing the final rule entitled “Nondiscrimination in
15 Health and Health Education Programs or Activi-
16 ties, Delegation of Authority” (85 Fed. Reg. 37160)
17 and dated June 19, 2020.
