Making appropriations for the Department of State, foreign operations, and related programs for the fiscal year ending September 30, 2025, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-

10	Administration of Foreign Affairs
11	DIPLOMATIC PROGRAMS
12	For necessary expenses of the Department of State
13	and the Foreign Service not otherwise provided for, includ-
14	ing for training, human resources management, and sala-
15	ries, including employment without regard to civil service
16	and classification laws of persons on a temporary basis
17	(not to exceed \$700,000), as authorized by section 801
18	of the United States Information and Educational Ex-
19	change Act of 1948 (62 Stat. 11; Chapter 36); for the
20	regional bureaus of the Department of State and overseas
21	activities as authorized by law; for the functional bureaus

- 16 Of the amounts deposited in the Consular and Border
- 17 Security Programs account in this or any prior fiscal year
- 18 pursuant to section 7069(e) of the Department of State,
- 19 Foreign Operations, and Related Programs Appropria-
- 20 tions Act, 2022 (division K of Public Law 117–103),
- 21 \$491,000,000 (increased by \$1,000,000) (reduced by
- 22 \$1,000,000) (increased by \$5,000,000) (reduced by

- 8 connection with, English teaching, educational advising
- 9 and counseling programs, and exchange visitor programs
- 10 as authorized may be credited to this account, to remain
- 11 available until expended: Provided further, That any sub-
- 12 stantive modifications from the prior fiscal year to pro-
- 13 grams funded under this heading in this Act shall be sub-
- 14 ject to prior consultation with, and the regular notification
- 15 procedures of, the Committees on Appropriations.
- 16 REPRESENTATION EXPENSES
- 17 For representation expenses as authorized,
- 18 \$7,415,000.
- 19 PROTECTION OF FOREIGN MISSIONS AND OFFICIALS
- For necessary expenses, not otherwise provided, to
- 21 enable the Secretary of State to provide for extraordinary
- 22 protective services, as authorized, \$30,890,000, to remain
- 23 available until September 30, 2026.

- 1 EMBASSY SECURITY, CONSTRUCTION, AND MAINTENANCE
- 2 For necessary expenses for carrying out the Foreign
- 3 Service Buildings Act of 1926 (22 U.S.C. 292 et seq.),
- 4 preserving, maintaining, repairing, and planning for real
- 5 property that are owned or leased by the Department of
- 6 State, and renovating, in addition to funds otherwise avail-
- 7 able, the Harry S Truman Building, \$945,210,000, to re-
- 8 main available until September 30, 2029, of which not to
- 9 exceed \$25,000 may be used for overseas representation
- 10 expenses as authorized: *Provided*, That none of the funds
- 11 appropriated in this paragraph shall be available for acqui-
- 12 sition of furniture, furnishings, or generators for other de-
- 13 partments and agencies of the United States Government.
- In addition, for the costs of worldwide security up-
- 15 grades, acquisition, and construction as authorized,
- 16 \$1,012,611,000, to remain available until expended.
- 17 EMERGENCIES IN THE DIPLOMATIC AND CONSULAR
- 18 SERVICE
- 19 For necessary expenses to enable the Secretary of
- 20 State to meet unforeseen emergencies arising in the Diplo-
- 21 matic and Consular Service, as authorized, \$8,885,000, to
- 22 remain available until expended, of which not to exceed
- 23 \$1,000,000 may be transferred to, and merged with, funds
- 24 appropriated by this Act under the heading "Repatriation
- 25 Loans Program Account".

2	For the cost of direct loans, \$1,800,000, as author-
3	ized: Provided, That such costs, including the cost of modi-

14	Not to exceed \$1,879,587 shall be derived from fees
15	collected from other executive agencies for lease or use of
16	facilities at the International Center in accordance with
17	section 4 of the International Center Act (Public Law 90–
18	553), and, in addition, as authorized by section 5 of such
19	Act, \$745,000, to be derived from the reserve authorized
20	by such section, to be used for the purposes set out in
21	that section.

1 International Organizations 2 CONTRIBUTIONS TO INTERNATIONAL ORGANIZATIONS 3 For necessary expenses, not otherwise provided for, to meet annual obligations of membership in international multilateral organizations, pursuant to treaties ratified pursuant to the advice and consent of the Senate, conventions, or specific Acts of Congress, \$269,614,000: Pro-8 vided, That the Secretary of State shall, at the time of the submission of the President's budget to Congress 10 under section 1105(a) of title 31, United States Code, transmit to the Committees on Appropriations the most recent biennial budget prepared by the United Nations for 12 the operations of the United Nations: Provided further, That the Secretary of State shall notify the Committees 14 15 on Appropriations at least 15 days in advance (or in an emergency, as far in advance as is practicable) of any 16 United Nations action to increase funding for any United 18 Nations program without identifying an offsetting decrease elsewhere in the United Nations budget: Provided 19 further, That any payment of arrearages under this head-21 ing shall be directed to activities that are mutually agreed upon by the United States and the respective international 23 organization and shall be subject to the regular notification procedures of the Committees on Appropriations: Pro-

vided further, That none of the funds appropriated under

- 3 States share of interest costs made known to the United

- 7 CONTRIBUTIONS FOR INTERNATIONAL PEACEKEEPING
- 8 ACTIVITIES
- 9 For necessary expenses to pay assessed and other ex-
- 10 penses of international peacekeeping activities directed to
- 11 the maintenance or restoration of international peace and
- 12 security, \$1,068,900,000, of which \$534,450,000 may re-
- 13 main available until September 30, 2026: Provided, That
- 14 none of the funds made available by this Act shall be obli-
- 15 gated or expended for any new or expanded United Na-
- 16 tions peacekeeping mission unless, at least 15 days in ad-
- 17 vance of voting for such mission in the United Nations
- 18 Security Council (or in an emergency as far in advance
- 19 as is practicable), the Committees on Appropriations are
- 20 notified of: (1) the estimated cost and duration of the mis-
- 21 sion, the objectives of the mission, the national interest
- 22 that will be served, and the exit strategy; and (2) the
- 23 sources of funds, including any reprogrammings or trans-
- 24 fers, that will be used to pay the cost of the new or ex-
- 25 panded mission, and the estimated cost in future fiscal

years: Provided further, That none of the funds appropriated under this heading may be made available for obli-3 gation unless the Secretary of State certifies and reports 4 to the Committees on Appropriations on a peacekeeping mission-by-mission basis that the United Nations is imple-6 menting effective policies and procedures to prevent United Nations employees, contractor personnel, and 8 peacekeeping troops serving in such mission from trafficking in persons, exploiting victims of trafficking, or 10 committing acts of sexual exploitation and abuse or other violations of human rights, and to hold accountable indi-12 viduals who engage in such acts while participating in such mission, including prosecution in their home countries and making information about such prosecutions 14 publicly available on the website of the United Nations: Provided further, That the Secretary of State shall work with the United Nations and foreign governments contributing peacekeeping troops to implement effective vetting 18 procedures to ensure that such troops have not violated 19 human rights: Provided further, That funds shall be avail-21 able for peacekeeping expenses unless the Secretary of State determines that United States manufacturers and 23 suppliers are not being given opportunities to provide equipment, services, and material for United Nations peacekeeping activities equal to those being given to for-

- 1 eign manufacturers and suppliers: Provided further, That
- 2 none of the funds appropriated or otherwise made avail-
- 3 able under this heading may be used for any United Na-
- 4 tions peacekeeping mission that will involve United States
- 5 Armed Forces under the command or operational control

- 7 sors have submitted to the President a recommendation
- 8 that such involvement is in the national interest of the

- 8 ada or Great Britain, and for grant programs of the North
- 9 American Development Bank, including technical assist-
- 10 ance grants and the Community Assistance Program,
- 11 \$17,300,000: Provided, That of the amount provided
- 12 under this heading for the International Joint Commis-
- 13 sion, up to \$1,250,000 may remain available until Sep-
- 14 tember 30, 2026, and up to \$9,000 may be made available
- 15 for representation expenses: Provided further, That of the
- 16 amount provided under this heading for the International
- 17 Boundary Commission, up to \$1,000 may be made avail-
- 18 able for representation expenses.

Act to carry out the provisions of chapter 1 of part I and chapters 4 and 6 of part II of the Foreign Assistance Act of 1961, may be used, notwithstanding section 660 of that Act, to enhance the effectiveness and accountability of civilian police authority through training and technical assistance in human rights, the rule of law, anti-corruption, strategic planning, and through assistance to foster civilian police roles that support democratic governance, including assistance for programs to prevent conflict, respond to disasters, address gender-based violence, and foster improved police relations with the communities they serve.

(2) Combat Casualty Care.—

(A) Consistent with the objectives of the Foreign Assistance Act of 1961 and the Arms Export Control Act, funds appropriated by this Act under the headings "Peacekeeping Operations" and "Foreign Military Financing Program" shall be made available for combat casualty training and equipment in an amount above the prior fiscal year.

(B) The Secretary of State shall offer combat casualty care training and equipment as a component of any package of lethal assistance funded by this Act with funds appropriated under the headings "Peacekeeping Operations" and "Foreign Military Financing Program": Provided, That the requirement of this subparagraph shall apply to a country in conflict, unless the Secretary determines that such country has in place, to the maximum extent practicable, functioning combat casualty care treatment and equipment that meets or exceeds the standards recommended by the Committee on Tactical Combat Casualty Care: Provided further, That any such training and equipment for combat casualty care shall be made available through an open and competitive process.

(b) Authorities.—

- (1) RECONSTITUTING CIVILIAN POLICE AUTHORITY.—In providing assistance with funds appropriated by this Act under section 660(b)(6) of the Foreign Assistance Act of 1961, support for a nation emerging from instability may be deemed to mean support for regional, district, municipal, or other sub-national entity emerging from instability, as well as a nation emerging from instability.
- (2) DISARMAMENT, DEMOBILIZATION, AND RE-INTEGRATION.—Section 7034(d) of the Department

- of State, Foreign Operations, and Related Programs
 Appropriations Act, 2015 (division J of Public Law
- 3 113–235) shall continue in effect during fiscal year 2025.
- 5 (3) Commercial leasing of defense arti-6 CLES.—Notwithstanding any other provision of law, 7 and subject to the regular notification procedures of 8 the Committees on Appropriations, the authority of 9 section 23(a) of the Arms Export Control Act (22) 10 U.S.C. 2763) may be used to provide financing to 11 Israel, Egypt, the North Atlantic Treaty Organiza-12 tion (NATO), and major non-NATO allies for the 13 procurement by leasing (including leasing with an 14 option to purchase) of defense articles from United 15 States commercial suppliers, not including Major 16 Defense Equipment (other than helicopters and 17 other types of aircraft having possible civilian appli-18 cation), if the President determines that there are 19 compelling foreign policy or national security reasons 20 for those defense articles being provided by commer-21 cial lease rather than by government-to-government 22 sale under such Act.
 - (4) Special defense acquisition fund.— Not to exceed \$900,000,000 may be obligated pursuant to section 51(c)(2) of the Arms Export Control

- Act (22 U.S.C. 2795(c)(2)) for the purposes of the Special Defense Acquisition Fund (the Fund), to remain available for obligation until September 30, 2027: *Provided*, That the provision of defense articles and defense services to foreign countries or international organizations from the Fund shall be subject to the concurrence of the Secretary of State.
 - (5) War reserve stockpile authority.—
 For fiscal year 2025, section 514(b) of the Foreign Assistance Act of 1961 (22 U.S.C. 2321h(b)) shall not apply to defense articles to be set aside, earmarked, reserved, or intended for use as reserve stocks in stockpiles in the State of Israel.
 - (6) Program Clarification.—Notwithstanding section 503(a)(3) of Public Law 87–195 (22 U.S.C. 2311(a)(3)), the procurement of defense articles and services funded on a non-repayable basis under section 23 of the Arms Export Control Act may be priced to include the costs of salaries of members of the Armed Forces of the United States engaged in security assistance activities pursuant to 10 U.S.C. 341 (relating to the State Partnership Program): *Provided*, That this paragraph shall only apply to funds that remain available for obligation in fiscal year 2025.

1 (7) Foreign military financing direct
2 Loans and Loan guarantees.—Section 2606(a)
3 of the Consolidated Appropriations Act, 2022 (Pub4 lie Law 117–103) shall continue in effect during fis5 cal year 2025 and shall apply to funds made avail6 able by this Act under the heading "Foreign Military Financing Program".

(c) Limitations.—

(1) CHILD SOLDIERS.—Funds appropriated by this Act should not be used to support any military training or operations that include child soldiers.

(2) Landmines and cluster munitions.—

- (A) Landmines.—Notwithstanding any other provision of law, demining equipment available to the United States Agency for International Development and the Department of State and used in support of the clearance of landmines and unexploded ordnance for humanitarian purposes may be disposed of on a grant basis in foreign countries, subject to such terms and conditions as the Secretary of State may prescribe.
- (B) Cluster munitions.—No military assistance shall be furnished for cluster munitions, no defense export license for cluster mu-

nitions may be issued, and no cluster munitions or cluster munitions technology shall be sold or transferred, unless—

- (i) the submunitions of the cluster munitions, after arming, do not result in more than 1 percent unexploded ordnance across the range of intended operational environments, and the agreement applicable to the assistance, transfer, or sale of such cluster munitions or cluster munitions technology specifies that the cluster munitions will only be used against clearly defined military targets and will not be used where civilians are known to be present or in areas normally inhabited by civilians; or
- (ii) such assistance, license, sale, or transfer is for the purpose of demilitarizing or permanently disposing of such cluster munitions.
- (3) CROWD CONTROL.—If the Secretary of State has information that a unit of a foreign security force uses excessive force to repress peaceful expression or assembly concerning corruption, harm to the environment or human health, or the fairness of electoral processes, or in countries that are undemo-

cratic or undergoing democratic transition, the Secretary shall promptly determine if such information is credible: *Provided*, That if the information is determined to be credible, funds appropriated by this Act should not be used for tear gas, small arms, light weapons, ammunition, or other items for crowd control purposes for such unit, unless the Secretary of State determines that the foreign government is taking effective measures to bring the responsible members of such unit to justice.

(4) Oversight and accountability.—

(A) Prior to the signing of a new Letter of Offer and Acceptance (LOA) involving funds appropriated under the heading "Foreign Military Financing Program", the Secretary of State shall consult with each recipient government to ensure that the LOA between the United States and such recipient government complies with the purposes of section 4 of the Arms Export Control Act (22 U.S.C. 2754) and that the defense articles, services, and training procured with funds appropriated under such heading are consistent with United States national security policy.

1 (B) The Secretary of State shall promptly
2 inform the appropriate congressional commit3 tees of any instance in which the Secretary of
4 State has credible information that such assist5 ance was used in a manner contrary to such

agreement.

- (5) Delivery of withheld items.—Any defense article and defense service withheld from delivery to Israel by the Department of State as of the date of enactment of this Act, including those contracted through Direct Commercial Sales for the Ministry of Public Security, shall be delivered to Israel not later than 15 days after the date of the enactment of this Act: *Provided*, That 50 percent of the funds appropriated or otherwise made available by this Act under the heading "Diplomatic Programs" and made available for the Office of the Secretary shall be withheld from obligation until the Secretary of State certifies and reports to the Committees on Appropriations that the defense articles and services described in this paragraph have been delivered to Israel.
 - (6) Obligation requirement.—The Secretary of State shall obligate any remaining unobligated balances of funds appropriated or otherwise
