SCOTT FRANKLIN of Florida, and Mr. WEBSTER of Florida) introduced the following bill; which was referred to the Committee on Natural Resources, and in addition to the Committee on Armed Services, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned

A BILL

To establish a moratorium on energy development in certain areas of the Gulf of Mexico, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Preserving the Gulf
5 Test Range to Ensure Military Readiness Act”.

1 **SEC. 2. MORATORIUM ON ENERGY DEVELOPMENT IN CER-**
2 **TAIN AREAS OF GULF OF MEXICO.**

3 (a) DEFINITIONS.—In this section:

4 (1) MILITARY MISSION LINE.—The term “Mili-
5 tary Mission Line” has the meaning given the term
6 in section 102 of the Gulf of Mexico Energy Security
7 Act of 2006 (43 U.S.C. 1331 note; Public Law 109–
8 432).

9 (2) SECRETARY.—The term “Secretary” means
10 the Secretary of the Interior.

11 (b) MORATORIUM.—Effective during the period be-
12 ginning on the date of enactment of this Act and ending
13 on June 30, 2032, the Secretary shall not offer for leasing,
14 preleasing, or any related activity for energy development
15 of any kind—

16 (1) any area east of the Military Mission Line
17 in the Gulf of Mexico; or

18 (2) any area of the outer Continental Shelf de-
19 scribed in subparagraph (A), (B), or (C) of para-
20 graph (2) of subsection (d), if oil, gas, wind, or any
21 other form of energy exploration, leasing, or develop-
22 ment in that area has been identified in a report
23 under that subsection as having any adverse effect
24 on the national security of the United States or the
25 military readiness or testing capabilities of the De-
26 partment of Defense.

1 (c) ENVIRONMENTAL EXCEPTIONS.—Notwith-
2 standing subsection (b), the Secretary may issue leases in
3 areas described in that subsection for environmental con-
4 servation purposes, including the purposes of shore protec-
5 tion, beach nourishment and restoration, wetlands restora-
6 tion, and habitat protection.

7 (d) REPORTS.—

8 (1) IN GENERAL.—Not later than 180 days
9 after the date of enactment of this Act, and not
10 later than June 30, 2031, the Secretary of Defense
11 shall submit to the Committees on Appropriations
12 and Armed Services of the Senate and the Commit-
13 tees on Appropriations and Armed Services of the
14 House of Representatives a report that describes the
15 impact of oil, gas, wind, and any other form of en-
16 ergy exploration, leasing, or development in areas of
17 the outer Continental Shelf described in paragraph
18 (2) on the national security of the United States and
19 the military readiness and testing capabilities of the
20 Department of Defense.

21 (2) AREAS DESCRIBED.—The areas of the outer
22 Continental Shelf referred to in paragraph (1) are
23 the following:

24 (A) Any area west of the Military Mission
25 Line in the Gulf of Mexico.

1 (B) The South Atlantic Planning Area.

2 (C) The Straits of Florida Planning Area.
