## **CONCURRENT RESOLUTION**

- 1 Resolved by the House of Representatives (the Senate
- 2 concurring), That when the House adjourns on any legisla-
- 3 tive day from Thursday, November 19, 2015, through
- 4 Wednesday, November 25, 2015, on a motion offered pur-
- 5 suant to this concurrent resolution by its Majority Leader
- 6 or his designee, it stand adjourned until 2:00 p.m. on
- 7 Monday, November 30, 2015, or until the time of any

- 1 reassembly pursuant to section 2 of this concurrent resolu-
- 2 tion, whichever occurs first; and that when the Senate re-
- 3 cesses or adjourns on any day from Thursday, November
- 4 19, 2015, through Tuesday, November 24, 2015, on a mo-
- 5 tion offered pursuant to this concurrent resolution by its
- 6 Majority Leader or his designee, it stand recessed or ad-
- 7 journed until noon on Monday, November 30, 2015, or
- 8 such other time on that day as may be specified by its
- 9 Majority Leader or his designee in the motion to recess
- 10 or adjourn, or until the time of any reassembly pursuant
- 11 to section 3 of this concurrent resolution, whichever occurs
- 12 first.
- 13 Sec. 2. (a) The Speaker or his designee, after con-
- 14 sultation with the Minority Leader of the House, shall no-
- 15 tify the Members of the House to reassemble at such place
- 16 and time as he may designate if, in his opinion, the public
- 17 interest shall warrant it.
- 18 (b) After reassembling pursuant to subsection (a),
- 19 when the House adjourns on a motion offered pursuant
- 20 to this subsection by its Majority Leader or his designee,
- 21 the House shall again stand adjourned pursuant to the
- 22 first section of this concurrent resolution.
- SEC. 3. (a) The Majority Leader of the Senate or his
- 24 designee, after concurrence with the Minority Leader of
- 25 the Senate, shall notify the Members of the Senate to reas-

- 1 semble at such place and time as he may designate if, in
- 2 his opinion, the public interest shall warrant it.
- 3 (b) After reassembling pursuant to subsection (a),
- 4 when the Senate adjourns on a motion offered pursuant
- 5 to this subsection by its Majority Leader or his designee,
- 6 the Senate shall again stand adjourned pursuant to the
- 7 first section of this concurrent resolution.
