# JOINT RESOLUTION

Proposing a balanced budget amendment to the Constitution of the United States.

1       *Resolved by the Senate and House of Representatives*  
2    *of the United States of America in Congress assembled*  
3    *(two-thirds of each House concurring therein), That the fol-*  
4    *lowing article is proposed as an amendment to the Con-*  
5    *stitution of the United States, which shall be valid to all*  
6    *intents and purposes as part of the Constitution when*  
7    *ratified by the legislatures of three-fourths of the several*  
8    *States:*

## 1                   “ARTICLE—

2        “SECTION 1. Total outlays for any fiscal year shall  
3   not exceed total receipts for that fiscal year.

4        “SECTION 2. Prior to each fiscal year, the President  
5   shall transmit to the Congress a proposed budget for the  
6   United States Government for that fiscal year in which  
7   total outlays do not exceed total receipts.

8        “SECTION 3. The Congress may waive the provisions  
9   of this article for any fiscal year in which a declaration  
10   of war is in effect. The provisions of this article may be  
11   waived for any fiscal year in which the United States is  
12   engaged in military conflict which causes an imminent and  
13   serious military threat to national security and is so de-  
14   clared by a joint resolution, adopted by a majority of the  
15   whole number of each House, which becomes law. Any  
16   such waiver shall identify and be limited to the specific  
17   increase for that fiscal year made necessary by the identi-  
18   fied military conflict. Any increase in spending related to  
19   any waiver provided by this section shall be offset by a  
20   budget surplus within ten fiscal years of the end of this  
21   waiver.

22       “SECTION 4. The Congress may waive the provisions  
23   of this article for any fiscal year in which a declaration  
24   of national emergency is in effect, as so declared by a joint  
25   resolution, adopted by a majority of the whole number of

1 each House, which becomes law. Any such waiver shall  
2 identify and be limited to the specific increase for that  
3 fiscal year made necessary by the identified national emer-  
4 gency. Any increase in spending related to any waiver pro-  
5 vided by this section shall be offset by a budget surplus  
6 within ten fiscal years of the end of this waiver.

7       “SECTION 5. The Congress shall enforce and imple-  
8 ment this article by appropriate legislation, which may rely  
9 on estimates of outlays and receipts.

10       “SECTION 6. Total receipts shall include all receipts  
11 of the United States Government except those derived  
12 from borrowing. Total outlays shall include all outlays of  
13 the United States Government except for those for repay-  
14 ment of debt principal.

15       “SECTION 7. This article shall take effect beginning  
16 with the tenth fiscal year after its ratification.”.
