# **JOINT RESOLUTION**

Approving the renewal of import restrictions contained in the Burmese Freedom and Democracy Act of 2003, and for other purposes.

- 1 Resolved by the Senate and House of Representatives
- 2 of the United States of America in Congress assembled,
- 3 SECTION 1. RENEWAL OF IMPORT RESTRICTIONS UNDER
- 4 BURMESE FREEDOM AND DEMOCRACY ACT
- 5 **OF 2003.**
- 6 (a) In General.—Congress approves the renewal of
- 7 the import restrictions contained in section 3(a)(1) and
- 8 section 3A (b)(1) and (c)(1) of the Burmese Freedom and
- 9 Democracy Act of 2003.

- 1 (b) Rule of Construction.—This joint resolution
- 2 shall be deemed to be a "renewal resolution" for purposes
- 3 of section 9 of the Burmese Freedom and Democracy Act
- 4 of 2003.

### 5 SEC. 2. CUSTOMS USER FEES.

- 6 Section 13031(j)(3)(B)(i) of the Consolidated Omni-
- 7 bus Budget Reconciliation Act of 1985 (19 U.S.C.
- 8 58c(j)(3)(B)(i) is amended by striking "August 17,
- 9 2018" and inserting "August 24, 2018".

### 10 SEC. 3. TIME FOR PAYMENT OF CORPORATE ESTIMATED

- 11 TAXES.
- The percentage under paragraph (2) of section 561
- 13 of the Hiring Incentives to Restore Employment Act in
- 14 effect on the date of the enactment of this Act is increased
- 15 by 0.25 percentage points.

### 16 SEC. 4. PAYGO COMPLIANCE.

- 17 The budgetary effects of this Act, for the purpose of
- 18 complying with the Statutory Pay-As-You-Go Act of 2010,
- 19 shall be determined by reference to the latest statement
- 20 titled "Budgetary Effects of PAYGO Legislation" for this
- 21 Act, submitted for printing in the Congressional Record
- 22 by the Chairman of the House Budget Committee, pro-
- 23 vided that such statement has been submitted prior to the
- 24 vote on passage.

### 1 SEC. 5. EFFECTIVE DATE.

- 2 This joint resolution and the amendments made by
- 3 this joint resolution shall take effect on the date of the
- 4 enactment of this joint resolution or July 26, 2010, which-
- 5 ever occurs earlier.
