## RESOLUTION

Expressing support for the recognition of October 1, 2018, through October 7, 2018, as “Smart Cities Week” and supporting the further research, development, and adoption of technology designed to improve efficiency, connectivity, sustainability, and mobility in transportation, infrastructure, and workforce opportunity in American cities and communities.

Whereas the term “smart technology” refers to a range of technologies and devices, including automation, artificial intelligence, wireless and wired communications, sensors, actuators, smart meters, “Internet of Things” devices,

data sharing, and data analytics, used in various applications to make cities and communities more efficient, resilient, and competitive;

Whereas the integration of smart technology has the potential to revolutionize connectivity, mobility, sustainability, and 21st century workforce opportunities in our Nation’s cities, regions, and communities;

Whereas, in 2015, the Department of Transportation released a report on the findings from the “Smart City Challenge”, in which 78 cities submitted innovative solutions to integrate technology to improve their city’s transportation infrastructure;

Whereas the findings of the “Smart City Challenge” signaled positive steps toward improving how people and goods are transported while expanding accessibility and opportunity;

Whereas the report also cited the integration of data platforms, combining public and private sector sources that allow policymakers to make more informed decisions on policy and budget issues; and

Whereas American investment in infrastructure could promote employment opportunities while spurring the next generation of telecommunications technology, including 5G and dedicated short range communications (DSRC) technology: Now, therefore, be it

- 1       *Resolved*, That the House of Representatives—
- 2               (1) recognizes “Smart Cities Week”; and
- 3               (2) supports efforts—
- 4                       (A) to further research and develop and
- 5                       adopt technology in American cities designed to

1 improve efficiency, connectivity, sustainability,  
2 and mobility in transportation and infrastruc-  
3 ture, including the implementation of 5G tele-  
4 communications and dedicated short range com-  
5 munications (DSRC) technology;

6 (B) to increase awareness of new work-  
7 force opportunities and expanded accessibility  
8 made available through “Smart City” initiatives  
9 and emerging industries in the 21st century  
10 economy; and

11 (C) to encourage the formation of public-  
12 private partnerships (or P3s) among the Fed-  
13 eral Government, the States, localities, commu-  
14 nities, the private sector, and key stakeholders  
15 to foster innovation when designing and imple-  
16 menting smart technology solutions.
