RESOLUTION

Providing for consideration of the bill (H.R. 6323) to modify the availability of certain waiver authorities with respect

to sanctions imposed with respect to the financial sector of Iran, and for other purposes; providing for consideration of the resolution (H. Res. 1143) condemning Iran's unprecedented drone and missile attack on Israel; providing for consideration of the bill (H.R. 4691) to provide for congressional review of actions to terminate or waive sanctions imposed with respect to Iran; providing for consideration of the bill (H.R. 5947) to provide for the rescission of certain waivers and licenses relating to Iran, and for other purposes; providing for consideration of the bill (H.R. 6046) to designate Ansarallah as a foreign terrorist organization and impose certain sanctions on Ansarallah, and for other purposes; and providing for consideration of the bill (H.R. 4639) to amend section 2702 of title 18, United States Code, to prevent law enforcement and intelligence agencies from obtaining subscriber or customer records in exchange for anything of value, to address communications and records in the possession of intermediary internet service providers, and for other purposes.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the bill (H.R.
3 6323) to modify the availability of certain waiver authori-
4 ties with respect to sanctions imposed with respect to the
5 financial sector of Iran, and for other purposes. All points
6 of order against consideration of the bill are waived. The
7 amendment in the nature of a substitute recommended by
8 the Committee on Financial Services now printed in the
9 bill shall be considered as adopted. The bill, as amended,
10 shall be considered as read. All points of order against

1 provisions in the bill, as amended, are waived. The pre-
2 vious question shall be considered as ordered on the bill,
3 as amended, and on any further amendment thereto, to
4 final passage without intervening motion except: (1) one
5 hour of debate equally divided and controlled by the chair
6 and ranking minority member of the Committee on Finan-
7 cial Services or their respective designees; and (2) one mo-
8 tion to recommit.

9 SEC. 2. Upon adoption of this resolution it shall be
10 in order without intervention of any point of order to con-
11 sider in the House the resolution (H. Res. 1143) con-
12 demning Iran's unprecedented drone and missile attack on
13 Israel. The resolution shall be considered as read. The pre-
14 vious question shall be considered as ordered on the reso-
15 lution and preamble to adoption without intervening mo-
16 tion or demand for division of the question except one hour
17 of debate equally divided and controlled by the chair and
18 ranking minority member of the Committee on Foreign
19 Affairs or their respective designees.

20 SEC. 3. Upon adoption of this resolution it shall be
21 in order to consider in the House the bill (H.R. 4691)
22 to provide for congressional review of actions to terminate
23 or waive sanctions imposed with respect to Iran. All points
24 of order against consideration of the bill are waived. An
25 amendment in the nature of a substitute consisting of the

1 text of Rules Committee Print 118–30 shall be considered
2 as adopted. The bill, as amended, shall be considered as
3 read. All points of order against provisions in the bill, as
4 amended, are waived. The previous question shall be con-
5 sidered as ordered on the bill, as amended, and on any
6 further amendment thereto, to final passage without inter-
7 vening motion except: (1) one hour of debate equally di-
8 vided and controlled by the chair and ranking minority
9 member of the Committee on Foreign Affairs or their re-
10 spective designees; and (2) one motion to recommit.

11 SEC. 4. Upon adoption of this resolution it shall be
12 in order to consider in the House the bill (H.R. 5947)
13 to provide for the rescission of certain waivers and licenses
14 relating to Iran, and for other purposes. All points of
15 order against consideration of the bill are waived. The bill
16 shall be considered as read. All points of order against
17 provisions in the bill are waived. The previous question
18 shall be considered as ordered on the bill and on any
19 amendment thereto to final passage without intervening
20 motion except: (1) one hour of debate equally divided and
21 controlled by the chair and ranking minority member of
22 the Committee on Foreign Affairs or their respective des-
23 ignees; and (2) one motion to recommit.

24 SEC. 5. Upon adoption of this resolution it shall be
25 in order to consider in the House the bill (H.R. 6046)

1 to designate Ansarallah as a foreign terrorist organization
2 and impose certain sanctions on Ansarallah, and for other
3 purposes. All points of order against consideration of the
4 bill are waived. In lieu of the amendment in the nature
5 of a substitute recommended by the Committee on Foreign
6 Affairs, an amendment in the nature of a substitute con-
7 sisting of the text of Rules Committee Print 118–29 shall
8 be considered as adopted. The bill, as amended, shall be
9 considered as read. All points of order against provisions
10 in the bill, as amended, are waived. The previous question
11 shall be considered as ordered on the bill, as amended,
12 and on any further amendment thereto, to final passage
13 without intervening motion except: (1) one hour of debate
14 equally divided and controlled by the chair and ranking
15 minority member of the Committee on Foreign Affairs or
16 their respective designees; and (2) one motion to recom-
17 mit.

18 SEC. 6. At any time after adoption of this resolution
19 the Speaker may, pursuant to clause 2(b) of rule XVIII,
20 declare the House resolved into the Committee of the
21 Whole House on the state of the Union for consideration
22 of the bill (H.R. 4639) to amend section 2702 of title 18,
23 United States Code, to prevent law enforcement and intel-
24 ligence agencies from obtaining subscriber or customer
25 records in exchange for anything of value, to address com-

1 munications and records in the possession of intermediary
2 internet service providers, and for other purposes. The
3 first reading of the bill shall be dispensed with. All points
4 of order against consideration of the bill are waived. Gen-
5 eral debate shall be confined to the bill and shall not ex-
6 ceed one hour equally divided and controlled by the chair
7 and ranking minority member of the Committee on the
8 Judiciary or their respective designees. After general de-
9 bate the bill shall be considered for amendment under the
10 five-minute rule. An amendment in the nature of a sub-
11 stitute consisting of the text of Rules Committee Print
12 118–28 shall be considered as adopted in the House and
13 in the Committee of the Whole. The bill, as amended, shall
14 be considered as the original bill for the purpose of further
15 amendment under the five-minute rule and shall be consid-
16 ered as read. All points of order against provisions in the
17 bill, as amended, are waived. No further amendment to
18 the bill, as amended, shall be in order except those printed
19 in the report of the Committee on Rules accompanying
20 this resolution. Each such further amendment may be of-
21 fered only in the order printed in the report, may be of-
22 fered only by a Member designated in the report, shall
23 be considered as read, shall be debatable for the time spec-
24 ified in the report equally divided and controlled by the
25 proponent and an opponent, shall not be subject to amend-

1 ment, and shall not be subject to a demand for division
2 of the question in the House or in the Committee of the
3 Whole. All points of order against such further amend-
4 ments are waived. At the conclusion of consideration of
5 the bill for amendment the Committee shall rise and re-
6 port the bill, as amended, to the House with such further
7 amendments as may have been adopted. The previous
8 question shall be considered as ordered on the bill, as
9 amended, and on any further amendment thereto to final
10 passage without intervening motion except one motion to
11 recommit.
