3 *nication, that refers or relates to the operation of the De-*
4 *partment of the Interior's Departmental Ethics Office and*
5 *the creation of ethics guidance, including the following:*

6 (1) *Any documents and communications relating*
7 *to the process for creating ethics compliance mate-*
8 *rials, including but not limited to any reference to—*

9 (A) *the creation of Ethics Guidance on*
10 *Recusal Obligations;*

11 (B) *the creation of Ethics Recusal and*
12 *Screening Arrangements;*

13 (C) *how the Departmental Ethics Office col-*
14 *lects information from political appointees; and*

15 (D) *how the Departmental Ethics Office*
16 *verifies the information provided by political ap-*
17 *pointees.*

18 (2) *Any documents and communications relating*
19 *to the time frame in which political appointees are*
20 *provided final ethics guidance.*

21 (3) *Any documents and communications relating*
22 *to ethics waivers for political appointees; including*
23 *but not limited to any reference to—*

24 (A) *requests for ethics waivers;*

25 (B) *denying an ethics waiver; and*

1 (C) *granting an ethics waiver.*

2 (4) *Any documents and communications relating*
3 *to the drafting and finalization of ethics guidance for*
4 *all Interior Department political appointees.*

5 (5) *Any meeting or communication that occurred*
6 *between the Designated Agency Ethics Official and all*
7 *Interior Department political appointees, relating to*
8 *the drafting and finalization of ethics guidance.*
