RESOLUTION

Providing for consideration of the bill (H.R. 5116) to invest in innovation through research and development, to improve the competitiveness of the United States, and for other purposes.

- 1 Resolved, That at any time after the adoption of this
- 2 resolution the Speaker may, pursuant to clause 2(b) of
- 3 rule XVIII, declare the House resolved into the Committee
- 4 of the Whole House on the state of the Union for consider-
- 5 ation of the bill (H.R. 5116) to invest in innovation

- 1 through research and development, to improve the com-
- 2 petitiveness of the United States, and for other purposes.
- 3 The first reading of the bill shall be dispensed with. All
- 4 points of order against consideration of the bill are waived
- 5 except those arising under clause 9 or 10 of rule XXI.
- 6 General debate shall be confined to the bill and shall not
- 7 exceed one hour equally divided and controlled by the chair
- 8 and ranking minority member of the Committee on
- 9 Science and Technology. After general debate the bill shall
- 10 be considered for amendment under the five-minute rule.
- 11 Sec. 2. (a) It shall be in order to consider as an origi-
- 12 nal bill for the purpose of amendment under the five-
- 13 minute rule the amendment in the nature of a substitute
- 14 recommended by the Committee on Science and Tech-
- 15 nology now printed in the bill modified by the amendment
- 16 printed in part A of the report of the Committee on Rules
- 17 accompanying this resolution. The committee amendment
- 18 in the nature of a substitute shall be considered as read.
- 19 All points of order against the committee amendment in
- 20 the nature of a substitute are waived except those arising
- 21 under clause 10 of rule XXI. (b) Notwithstanding clause
- 22 11 of rule XVIII, no amendment to the committee amend-
- 23 ment in the nature of a substitute shall be in order except
- 24 those printed in part B of the report of the Committee
- 25 on Rules accompanying this resolution and amendments

- 1 en bloc described in section 3 of this resolution. (c) Each
- 2 amendment printed in part B of the report of the Com-
- 3 mittee on Rules may be considered only in the order print-
- 4 ed in the report, may be offered only by a Member des-
- 5 ignated in the report, shall be considered as read, shall
- 6 be debatable for the time specified in the report equally
- 7 divided and controlled by the proponent and an opponent,
- 8 shall not be subject to amendment, and shall not be sub-
- 9 ject to a demand for division of the question. (d) All points
- 10 of order against amendments printed in part B of the re-
- 11 port of the Committee on Rules or amendments en bloc
- 12 described in section 3 of this resolution are waived except
- 13 those arising under clause 9 or 10 of rule XXI.
- 14 Sec. 3. It shall be in order at any time for the chair
- 15 of the Committee on Science and Technology or his des-
- 16 ignee to offer amendments en bloc consisting of amend-
- 17 ments printed in part B of the report of the Committee
- 18 on Rules accompanying this resolution not earlier disposed
- 19 of. Amendments en bloc offered pursuant to this section
- 20 shall be considered as read, shall be debatable for 40 min-
- 21 utes equally divided and controlled by the chair and rank-
- 22 ing minority member of the Committee on Science and
- 23 Technology or their designees, shall not be subject to
- 24 amendment, and shall not be subject to a demand for divi-
- 25 sion of the question. The original proponent of an amend-

- 1 ment included in such amendments en bloc may insert a
- 2 statement in the Congressional Record immediately before
- 3 the disposition of the amendments en bloc.
- 4 Sec. 4. At the conclusion of consideration of the bill
- 5 for amendment the Committee shall rise and report the
- 6 bill to the House with such amendments as may have been
- 7 adopted. The previous question shall be considered as or-
- 8 dered on the bill and amendments thereto to final passage
- 9 without intervening motion except one motion to recommit
- 10 with or without instructions.
- 11 Sec. 5. The Chair may entertain a motion that the
- 12 Committee rise only if offered by the chair of the Com-
- 13 mittee on Science and Technology or his designee. The
- 14 Chair may not entertain a motion to strike out the enact-
- 15 ing words of the bill (as described in clause 9 of rule
- 16 XVIII).
