Mr. SESSIONS, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

## RESOLUTION

Providing for consideration of the bill (H.R. 1004) to amend chapter 3 of title 5, United States Code, to require the publication of information relating to pending agency regulatory actions, and for other purposes, and providing for consideration of the bill (H.R. 1009) to amend title 44, United States Code, to require the Administrator of the Office of Information and Regulatory Affairs to review regulations, and for other purposes.

1       *Resolved*, That at any time after adoption of this reso-  
2 lution the Speaker may, pursuant to clause 2(b) of rule  
3 XVIII, declare the House resolved into the Committee of  
4 the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 1004) to amend chapter 3 of title  
6 5, United States Code, to require the publication of infor-  
7 mation relating to pending agency regulatory actions, and  
8 for other purposes. The first reading of the bill shall be  
9 dispensed with. All points of order against consideration  
10 of the bill are waived. General debate shall be confined  
11 to the bill and shall not exceed one hour equally divided  
12 and controlled by the chair and ranking minority member  
13 of the Committee on Oversight and Government Reform.  
14 After general debate the bill shall be considered for  
15 amendment under the five-minute rule. The bill shall be  
16 considered as read. All points of order against provisions  
17 in the bill are waived. No amendment to the bill shall be  
18 in order except those printed in part A of the report of  
19 the Committee on Rules accompanying this resolution.  
20 Each such amendment may be offered only in the order  
21 printed in the report, may be offered only by a Member  
22 designated in the report, shall be considered as read, shall  
23 be debatable for the time specified in the report equally  
24 divided and controlled by the proponent and an opponent,  
25 shall not be subject to amendment, and shall not be sub-

1 ject to a demand for division of the question in the House  
2 or in the Committee of the Whole. All points of order  
3 against such amendments are waived. At the conclusion  
4 of consideration of the bill for amendment the Committee  
5 shall rise and report the bill to the House with such  
6 amendments as may have been adopted. The previous  
7 question shall be considered as ordered on the bill and  
8 amendments thereto to final passage without intervening  
9 motion except one motion to recommit with or without in-  
10 structions.

11       SEC. 2. At any time after adoption of this resolution  
12 the Speaker may, pursuant to clause 2(b) of rule XVIII,  
13 declare the House resolved into the Committee of the  
14 Whole House on the state of the Union for consideration  
15 of the bill (H.R. 1009) to amend title 44, United States  
16 Code, to require the Administrator of the Office of Infor-  
17 mation and Regulatory Affairs to review regulations, and  
18 for other purposes. The first reading of the bill shall be  
19 dispensed with. All points of order against consideration  
20 of the bill are waived. General debate shall be confined  
21 to the bill and shall not exceed one hour equally divided  
22 and controlled by the chair and ranking minority member  
23 of the Committee on Oversight and Government Reform.  
24 After general debate the bill shall be considered for  
25 amendment under the five-minute rule. It shall be in order

1 to consider as an original bill for the purpose of amend-  
2 ment under the five-minute rule an amendment in the na-  
3 ture of a substitute consisting of the text of Rules Com-  
4 mittee Print 115-4. That amendment in the nature of a  
5 substitute shall be considered as read. All points of order  
6 against that amendment in the nature of a substitute are  
7 waived. No amendment to that amendment in the nature  
8 of a substitute shall be in order except those printed in  
9 part B of the report of the Committee on Rules accom-  
10 panying this resolution. Each such amendment may be of-  
11 fered only in the order printed in the report, may be of-  
12 fered only by a Member designated in the report, shall  
13 be considered as read, shall be debatable for the time spec-  
14 ified in the report equally divided and controlled by the  
15 proponent and an opponent, shall not be subject to amend-  
16 ment, and shall not be subject to a demand for division  
17 of the question in the House or in the Committee of the  
18 Whole. All points of order against such amendments are  
19 waived. At the conclusion of consideration of the bill for  
20 amendment the Committee shall rise and report the bill  
21 to the House with such amendments as may have been  
22 adopted. Any Member may demand a separate vote in the  
23 House on any amendment adopted in the Committee of  
24 the Whole to the bill or to the amendment in the nature  
25 of a substitute made in order as original text. The previous

1 question shall be considered as ordered on the bill and  
2 amendments thereto to final passage without intervening  
3 motion except one motion to recommit with or without in-  
4 structions.
