- 16 sider in the House, without intervention of any point of
- 17 order except those arising under clause 10 of rule XXI,
- 18 a motion offered by the chair of the Committee on Ways
- 19 and Means or his designee that the House concur in the
- 20 Senate amendment to the House amendment to the Sen-
- 21 ate amendment with the amendment printed in the report
- 22 of the Committee on Rules accompanying this resolution.
- 23 The previous question shall be considered as ordered on
- 24 the motion to final adoption without intervening motion.

7	Sec. 4. Until completion of proceedings enabled by
