Mr. BISHOP of Utah, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

## RESOLUTION

Providing for consideration of the bill (H.R. 527) to amend the Helium Act to complete the privatization of the Federal helium reserve in a competitive market fashion that ensures stability in the helium markets while protecting the interests of American taxpayers, and for other purposes.

1       *Resolved*, That at any time after the adoption of this  
2 resolution the Speaker may, pursuant to clause 2(b) of  
3 rule XVIII, declare the House resolved into the Committee

1 of the Whole House on the state of the Union for consider-  
2 ation of the bill (H.R. 527) to amend the Helium Act to  
3 complete the privatization of the Federal helium reserve  
4 in a competitive market fashion that ensures stability in  
5 the helium markets while protecting the interests of Amer-  
6 ican taxpayers, and for other purposes. The first reading  
7 of the bill shall be dispensed with. All points of order  
8 against consideration of the bill are waived. General de-  
9 bate shall be confined to the bill and shall not exceed one  
10 hour equally divided and controlled by the chair and rank-  
11 ing minority member of the Committee on Natural Re-  
12 sources. After general debate the bill shall be considered  
13 for amendment under the five-minute rule. In lieu of the  
14 amendment in the nature of a substitute recommended by  
15 the Committee on Natural Resources now printed in the  
16 bill, it shall be in order to consider as an original bill for  
17 the purpose of amendment under the five-minute rule an  
18 amendment in the nature of a substitute consisting of the  
19 text of Rules Committee Print 113-9. That amendment  
20 in the nature of a substitute shall be considered as read.  
21 All points of order against that amendment in the nature  
22 of a substitute are waived. No amendment to that amend-  
23 ment in the nature of a substitute shall be in order except  
24 those printed in the report of the Committee on Rules ac-  
25 companying this resolution. Each such amendment may

1 be offered only in the order printed in the report, may  
2 be offered only by a Member designated in the report,  
3 shall be considered as read, shall be debatable for the time  
4 specified in the report equally divided and controlled by  
5 the proponent and an opponent, shall not be subject to  
6 amendment, and shall not be subject to a demand for divi-  
7 sion of the question in the House or in the Committee  
8 of the Whole. All points of order against such amendments  
9 are waived. At the conclusion of consideration of the bill  
10 for amendment the Committee shall rise and report the  
11 bill to the House with such amendments as may have been  
12 adopted. Any Member may demand a separate vote in the  
13 House on any amendment adopted in the Committee of  
14 the Whole to the bill or to the amendment in the nature  
15 of a substitute made in order as original text. The previous  
16 question shall be considered as ordered on the bill and  
17 amendments thereto to final passage without intervening  
18 motion except one motion to recommit with or without in-  
19 structions.

20       SEC. 2. On any legislative day during the period from  
21 April 27, 2013, through May 3, 2013—

22       (a) the Journal of the proceedings of the previous day  
23 shall be considered as approved; and

24       (b) the Chair may at any time declare the House ad-  
25 journed to meet at a date and time, within the limits of

1 clause 4, section 5, article I of the Constitution, to be an-  
2 nounced by the Chair in declaring the adjournment.

3       SEC. 3. The Speaker may appoint Members to per-  
4 form the duties of the Chair for the duration of the period  
5 addressed by section 2 of this resolution as though under  
6 clause 8(a) of rule I.

7       SEC. 4. The Committee on Education and the Work-  
8 force may, at any time before 5 p.m. on Tuesday, April  
9 30, 2013, file a report to accompany H.R. 1406.
