- 5 late tobacco products. All points of order against consider-

- 1 ation of the bill are waived except those arising under
- 2 clause 9 or 10 of rule XXI. The amendment printed in
- 3 part A of the report of the Committee on Rules accom-
- 4 panying this resolution shall be considered as adopted.
- 5 The bill, as amended, shall be considered as read. All
- 6 points of order against provisions in the bill, as amended,
- 7 are waived. The previous question shall be considered as
- 8 ordered on the bill, as amended, to final passage without
- 9 intervening motion except: (1) one hour of debate on the
- 10 bill, as amended, equally divided and controlled by the
- 11 chair and ranking minority member of the Committee on
- 12 Energy and Commerce; (2) the amendment in the nature
- 13 of a substitute printed in part B of the report on the Com-
- 14 mittee on Rules, if offered by Representative Buyer of In-
- 15 diana, or his designee, which shall be in order without
- 16 intervention of any point of order except those arising
- 17 under clause 9 or 10 of rule XXI, shall be considered as
- 18 read, and shall be separately debatable for thirty minutes
- 19 equally divided and controlled by the proponent and an
- 20 opponent; and (3) one motion to recommit with or without
- 21 instructions.
- Sec. 2. (a) In the engrossment of H.R. 1256, the
- 23 Clerk shall—
- 24 (1) add the text of H.R. 1804, as passed by the
- 25 House, as new matter at the end of H.R. 1256;

1 (2) conform the title of H.R. 1256 to reflect the
2 addition to the engrossment of H.R. 1804;
3 (3) assign appropriate designations to provisions within the engrossment; and
5 (4) conform provisions for short titles within
6 the engrossment.
7 (b) Upon the addition of the text of H.R. 1804 to

the engrossment of H.R. 1256, H.R. 1804 shall be laid
