Impeaching Donald John Trump, President of the United States, for high crimes and misdemeanors.

IN THE HOUSE OF REPRESENTATIVES

JANUARY 12, 2021

Mr. GREEN of Texas submitted the following resolution; which was referred to the Committee on the Judiciary

RESOLUTION

Impeaching Donald John Trump, President of the United States, for high crimes and misdemeanors.

1 *Resolved*, That Donald John Trump, President of the
2 United States is impeached for high crimes and mis-
3 demeanors, and that the following articles of impeachment
4 be exhibited to the Senate:

5 Articles of Impeachment exhibited by the House of
6 Representatives of the United States, in the name of itself
7 and of the people of the United States, against Donald
8 John Trump, President of the United States, in mainte-
9 nance and support of its impeachment against him for
10 high crimes and misdemeanors.

1 ARTICLE I: WEAPONIZATION OF HATE

2 In his conduct while President of the United States,
3 unmindful of the high duties of his high office and the
4 dignity and proprieties thereof, and of the harmony and
5 courtesies necessary for stability within the society of the
6 United States, Donald John Trump—in violation of his
7 constitutional oath faithfully to execute the office of Presi-
8 dent of the United States and, to the best of his ability,
9 preserve, protect and defend the Constitution of the
10 United States, and, in violation of his constitutional duty
11 to take care that the laws be faithfully executed—has
12 harmed the society of the United States, brought shame
13 and dishonor to the office of the President of the United
14 States, sowing discord among the people of the United
15 States by weaponizing hate for political gain.

16 On December 19, 2020, President Donald John
17 Trump tweeted, promoting a protest in Washington, DC,
18 to be held in the weeks to come: “Big protest in D.C. on
19 January 6th. Be there, will be wild!”.

20 On January 6, 2021, in a speech at the National
21 Mall, President Donald John Trump weaponized the hate
22 that resulted in violence, the deaths of multiple people,
23 an assault on democracy, and an insurrection against the
24 Capitol of the United States of America, by inciting a
25 mob, infected with white supremacists, carrying a rebel

1 flag, erecting a gallows structure with a noose, wearing
2 shirts with hateful messages, such as “Camp Auschwitz:
3 Work Brings Freedom” and “MAGA Civil War January
4 6, 2021”. He told them:

5 “All of us here today do not want to see our
6 election victory stolen by a bold and radical left
7 Democrats, which is what they are doing, and stolen
8 by the fake news media. That is what they have
9 done and what they are doing. We will never give
10 up. We will never concede. It doesn’t happen. You
11 don’t concede when there’s theft involved.”.

12 The President further emboldened them, saying:
13 “. . . you’ll never take back our country with weakness.
14 You have to show strength and you have to be strong.”.

15 After his National Mall speech, a mob of his sup-
16 porters proceeded to the Capitol complex, breaching its se-
17 curity for approximately six hours. They—without wearing
18 face coverings—broke windows and spread blood and fecal
19 matter in the hallways.

20 As further evidence of President Donald John
21 Trump’s complicity, when things became unmanageable,
22 he said, in a video posted to Twitter: “These are the things
23 and events that happen when a sacred landslide election
24 victory is so unceremoniously and viciously stripped away

1 from great patriots who have been badly and unfairly
2 treated for so long.”.

3 The President finally told the insurrectionists to go
4 home, saying: “So go home, we love you, you’re very spe-
5 cial, you’ve seen what happens, you’ve seen the way others
6 are treated that are so bad and so evil. I know how you
7 feel but go home and go home in peace.”.

8 In all of this, the aforementioned Donald John
9 Trump has weaponized hate, by his statements, unmindful
10 of the high duties of his high office and the dignities and
11 proprieties thereof and of the harmony, respect, and cour-
12 tesies necessary for stability within the society of the
13 United States, has undermined the integrity of his high
14 office, has sown discord among the people of the United
15 States, has brought disrepute, contempt, ridicule and dis-
16 grace on the Presidency, has acted in a manner subversive
17 to the rule of law and justice resulting in lives lost, and
18 has betrayed his trust as President to the manifest injury
19 of the people of the United States.

20 Wherefore, to prevent additional harm to society,
21 Donald John Trump by such conduct warrants immediate
22 impeachment, trial, and removal from office and disquali-
23 fication to hold and enjoy any office of honor, trust or
24 profit under the United States.
