## RESOLUTION

Providing for consideration of the joint resolution (H.J. Res. 70) making continuing appropriations for National Park Service operations, the Smithsonian Institution, the Na-

tional Gallery of Art, and the United States Holocaust Memorial Museum for fiscal year 2014, and for other purposes; providing for consideration of the joint resolution (H.J. Res. 71) making continuing appropriations of local funds of the District of Columbia for fiscal year 2014; providing for consideration of the joint resolution (H.J. Res. 72) making continuing appropriations for veterans benefits for fiscal year 2014, and for other purposes; providing for consideration of the joint resolution (H.J. Res. 73) making continuing appropriations for the National Institutes of Health for fiscal year 2014, and for other purposes; providing for consideration of the bill (H.R. 3230) making continuing appropriations during a Government shutdown to provide pay and allowances to members of the reserve components of the Armed Forces who perform inactive-duty training during such period; and providing for consideration of motions to suspend the rules.

1       *Resolved*, That upon adoption of this resolution it  
2 shall be in order to consider in the House any joint resolu-  
3 tion specified in section 2 of this resolution. All points of  
4 order against consideration of each such joint resolution  
5 are waived. Each such joint resolution shall be considered  
6 as read. All points of order against provisions in each such  
7 joint resolution are waived. The previous question shall be  
8 considered as ordered on each such joint resolution and  
9 on any amendment thereto to final passage without inter-  
10 vening motion except: (1) 30 minutes of debate equally  
11 divided and controlled by the chair and ranking minority

1 member of the Committee on Appropriations; and (2) one  
2 motion to recommit.

3       SEC. 2. The joint resolutions reffered to in the first  
4 section of this resolution are as follows:

5       (a) The joint resolution (H.J. Res. 70) making con-  
6 tinuing appropriations for National Park Service oper-  
7 ations, the Smithsonian Institution, the National Gallery  
8 of Art, and the United States Holocaust Memorial Mu-  
9 seum for fiscal year 2014, and for other purposes.

10       (b) The joint resolution (H.J. Res. 71) making con-  
11 tinuing appropriations of local funds of the District of Co-  
12 lumbia for fiscal year 2014.

13       (c) The joint resolution (H.J. Res. 72) making con-  
14 tinuing appropriations for veterans benefits for fiscal year  
15 2014, and for other purposes.

16       (d) The joint resolution (H.J. Res. 73) making con-  
17 tinuing appropriations for the National Institutes of  
18 Health for fiscal year 2014, and for other purposes.

19       SEC. 3. Upon adoption of this resolution it shall be  
20 in order to consider in the House the bill (H.R. 3230)  
21 making continuing appropriations during a Government  
22 shutdown to provide pay and allowances to members of  
23 the reserve components of the Armed Forces who perform  
24 inactive-duty training during such period. All points of  
25 order against consideration of the bill are waived. The bill

1 shall be considered as read. All points of order against  
2 provisions in the bill are waived. The previous question  
3 shall be considered as ordered on the bill and on any  
4 amendment thereto to final passage without intervening  
5 motion except: (1) 30 minutes of debate equally divided  
6 and controlled by the chair and ranking minority member  
7 of the Committee on Appropriations; and (2) one motion  
8 to recommit.

9       SEC. 4. It shall be in order at any time through the  
10 calendar day of October 6, 2013, for the Speaker to enter-  
11 tain motions that the House suspend the rules as though  
12 under clause 1 of rule XV. The Speaker or his designee  
13 shall consult with the Minority Leader or her designee on  
14 the designation of any matter for consideration pursuant  
15 to this section.
