Mr. COLE, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 2842) to provide for the conduct of demonstration projects to test the effectiveness of subsidized employment for TANF recipients, and providing for consideration of motions to suspend the rules.

- 1 *Resolved*, That at any time after adoption of this reso-
- 2 lution the Speaker may, pursuant to clause 2(b) of rule
- 3 XVIII, declare the House resolved into the Committee of
- 4 the Whole House on the state of the Union for consider-
- 5 ation of the bill (H.R. 2842) to provide for the conduct

1 of demonstration projects to test the effectiveness of sub-
2 sidized employment for TANF recipients. The first read-
3 ing of the bill shall be dispensed with. All points of order
4 against consideration of the bill are waived. General de-
5 bate shall be confined to the bill and shall not exceed one
6 hour equally divided and controlled by the chair and rank-
7 ing minority member of the Committee on Ways and
8 Means. After general debate the bill shall be considered
9 for amendment under the five-minute rule. In lieu of the
10 amendment in the nature of a substitute recommended by
11 the Committee on Ways and Means now printed in the
12 bill, it shall be in order to consider as an original bill for
13 the purpose of amendment under the five-minute rule an
14 amendment in the nature of a substitute consisting of the
15 text of Rules Committee Print 115-22. That amendment
16 in the nature of a substitute shall be considered as read.
17 All points of order against that amendment in the nature
18 of a substitute are waived. No amendment to that amend-
19 ment in the nature of a substitute shall be in order except
20 those printed in the report of the Committee on Rules ac-
21 companying this resolution. Each such amendment may
22 be offered only in the order printed in the report, may
23 be offered only by a Member designated in the report,
24 shall be considered as read, shall be debatable for the time
25 specified in the report equally divided and controlled by

1 the proponent and an opponent, shall not be subject to
2 amendment, and shall not be subject to a demand for divi-
3 sion of the question in the House or in the Committee
4 of the Whole. All points of order against such amendments
5 are waived. At the conclusion of consideration of the bill
6 for amendment the Committee shall rise and report the
7 bill to the House with such amendments as may have been
8 adopted. Any Member may demand a separate vote in the
9 House on any amendment adopted in the Committee of
10 the Whole to the bill or to the amendment in the nature
11 of a substitute made in order as original text. The previous
12 question shall be considered as ordered on the bill and
13 amendments thereto to final passage without intervening
14 motion except one motion to recommit with or without in-
15 structions.

16 SEC. 2. It shall be in order at any time on the legisla-
17 tive day of June 22, 2017, for the Speaker to entertain
18 motions that the House suspend the rules, as though
19 under clause 1 of rule XV, relating to the bill (H.R. 2353)
20 to reauthorize the Carl D. Perkins Career and Technical
21 Education Act of 2006.
