## RESOLUTION

Of inquiry requesting the President to provide certain documents relating to the operations of U.S. Customs and Border Protection.

1       *Resolved*, That the House of Representatives requests  
2 the President, to the extent that such information is in  
3 the possession of the President, to transmit to the House  
4 of Representatives, not later than 14 days after the date  
5 of the adoption of this resolution, copies of any document,  
6 record, memorandum, correspondence, or other commu-  
7 nication or any portion of any such communication, that  
8 refers or relates to the following:

1           (1) Executive orders to repeal or rescind poli-  
2           cies in effect before January 20, 2021, with respect  
3           to the operations of U.S. Customs and Border Pro-  
4           tection (CBP) at the southern border of the United  
5           States.

6           (2) With respect to migrants who unlawfully  
7           entered the United States and were apprehended by  
8           CBP since January 20, 2021, information relating  
9           to—

10                   (A) the total number of such migrants;

11                   (B) the number of such migrants referred  
12           to in subparagraph (A) who are male, includ-  
13           ing—

14                           (i) the number of adults;

15                           (ii) the number of such adults who are  
16           single; and

17                           (iii) the number of unaccompanied  
18           alien children (as such term is defined in  
19           section 462(g)(2) of the Homeland Secu-  
20           rity Act of 2002 (6 U.S.C. 279(g)(2)));

21                   (C) the number of such migrants referred  
22           to in subparagraph (A) who are female, includ-  
23           ing—

24                           (i) the number of adults;

1 (ii) the number of such adults who are  
2 single; and

3 (iii) the number of unaccompanied  
4 alien children;

5 (D) the number of such migrants referred  
6 to in subparagraph (A) who are members of a  
7 family unit with a child 6 years old or younger;  
8 and

9 (E) the number of such migrants referred  
10 to in subparagraph (A) who are members of a  
11 family unit without a child 6 years old or  
12 younger.

13 (3) With respect to migrants who unlawfully  
14 entered the United States and were subject to expul-  
15 sion pursuant to section 362 of the Public Health  
16 Service Act (42 U.S.C. 265), information relating  
17 to—

18 (A) the total number of such migrants;

19 (B) the number of such migrants referred  
20 to in subparagraph (A) who are male, includ-  
21 ing—

22 (i) the number of adults;

23 (ii) the number of such adults who are  
24 single; and

1 (iii) the number of unaccompanied  
2 alien children;

3 (C) the number of such migrants referred  
4 to in subparagraph (A) who are female, includ-  
5 ing—

6 (i) the number of adults;

7 (ii) the number of such adults who are  
8 single; and

9 (iii) the number of unaccompanied  
10 alien children;

11 (D) the number of such migrants referred  
12 to in subparagraph (A) who are members of a  
13 family unit with a child 6 years old or younger;  
14 and

15 (E) the number of such migrants referred  
16 to in subparagraph (A) who are members of a  
17 family unit without a child 6 years old or  
18 younger.

19 (4) Information relating to the number of CBP  
20 agents, since January 20, 2021, who were reas-  
21 signed from a U.S. Border Patrol sector located in  
22 Arizona, California, New Mexico, or Texas to a facil-  
23 ity that shelters migrants who unlawfully entered  
24 the United States.

1           (5) Information relating to the number of  
2 agents from the Office of Field Operations, since  
3 January 20, 2021, who were reassigned from a U.S.  
4 Border Patrol sector to a facility that shelters mi-  
5 grants who unlawfully entered the United States.

6           (6) Information relating to the number of mi-  
7 grants who unlawfully entered the United States,  
8 since January 20, 2021, who—

9           (A) tested positive for the virus responsible  
10 for COVID–19 in the custody of CBP;

11           (B) received a COVID–19 vaccination  
12 while in the custody of CBP; and

13           (C) were released from the custody of CBP  
14 while infected with such virus.

15           (7) Since January 20, 2021, with respect to mi-  
16 grants who unlawfully entered the United States,  
17 were apprehended by CBP, and were subsequently  
18 released into the United States, information relating  
19 to—

20           (A) the identification of the city or State  
21 where such migrants are residing; and

22           (B) the number of such migrants who re-  
23 ceived a notice to report to an Immigration and  
24 Customs Enforcement office, and—

25           (i) did so appear; and

1 (ii) did not so appear.

2 (8) Information relating to the number of—

3 (A) unaccompanied alien children who un-  
4 lawfully entered the United States and were ap-  
5 prehended by CBP since January 20, 2021;

6 (B) such children who have been released  
7 to a sponsor within the United States; and

8 (C) such sponsors subjected to a back-  
9 ground investigation performed by the Federal  
10 Bureau of Investigation.

11 (9) Since January 20, 2021, with respect to mi-  
12 grants who unlawfully entered the United States,  
13 were apprehended by CBP, and have a connection to  
14 a Mexican drug cartel, information relating to—

15 (A) the number of such migrants;

16 (B) the name of each such cartel;

17 (C) the type of connection such migrants  
18 have to such cartels; and

19 (D) the type of assistance received by such  
20 migrants from such cartels.

21 (10) Information relating to migrants who have  
22 unlawfully entered the United States, since January  
23 20, 2021, who—

24 (A) were apprehended by CBP; and

1           (B) are included on a list maintained by  
2           the Federal Government relating to terrorism  
3           or individuals prohibited from boarding a com-  
4           mercial aircraft.

5           (11) Information relating to the temporary  
6           CBP facility in Donna, Texas, including—

7           (A) with respect to funding for such facil-  
8           ity, the Administration responsible for such  
9           funding;

10          (B) the date on which such facility was  
11          first used to shelter migrants who unlawfully  
12          entered the United States; and

13          (C) the number of such migrants sheltered  
14          in such facility since January 20, 2021.

15          (12) Since January 20, 2021, with respect to  
16          temporary influx facilities, information relating to—

17               (A) the total number of such facilities;

18               (B) the number of such facilities that—

19                     (i) were previously used as such facili-  
20                     ties;

21                     (ii) are convention centers;

22                     (iii) are military bases;

23                     (iv) have exceeded maximum capacity;

24                     and

1 (v) are operating with nonhabitable  
2 living conditions, including—

3 (I) nonpotable water; or

4 (II) other sanitary issues;

5 (C) the total number of migrants who un-  
6 lawfully entered the United States and are liv-  
7 ing in such a facility;

8 (D) the number of such migrants referred  
9 to in subparagraph (C) who are male, includ-  
10 ing—

11 (i) the number of adults;

12 (ii) the number of such adults who are  
13 single; and

14 (iii) the number of unaccompanied  
15 alien children;

16 (E) the number of such migrants referred  
17 to in subparagraph (C) who are female, includ-  
18 ing—

19 (i) the number of adults;

20 (ii) the number of such adults who are  
21 single; and

22 (iii) the number of unaccompanied  
23 alien children;

24 (F) the number of such migrants referred  
25 to in subparagraph (C) who are members of a

1 family unit with a child 6 years old or younger;  
2 and

3 (G) the number of such migrants referred  
4 to in subparagraph (C) who are members of a  
5 family unit without a child 6 years old or  
6 younger.

7 (13) The total amount of Federal funds obli-  
8 gated or expended for expenses relating to the care  
9 of migrants who unlawfully entered the United  
10 States since January 20, 2021, including—

11 (A) housing;

12 (B) shelter services and resources, includ-  
13 ing—

14 (i) personnel;

15 (ii) infrastructure;

16 (iii) utilities and food;

17 (iv) education; and

18 (v) health care, including—

19 (I) COVID–19 testing and vac-  
20 cinations; and

21 (II) personal protective equip-  
22 ment; and

23 (C) transportation, including by—

24 (i) vehicle; and
