Mr. POLIS of Colorado, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 3221) to amend the Higher Education Act of 1965, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 3221) to amend the Higher Edu-
6 cation Act of 1965, and for other purposes. The first read-
7 ing of the bill shall be dispensed with. All points of order

1 against consideration of the bill are waived except those
2 arising under clause 9 or 10 of rule XXI. General debate
3 shall be confined to the bill and shall not exceed one hour
4 equally divided and controlled by the chair and ranking
5 minority member of the Committee on Education and
6 Labor. After general debate the bill shall be considered
7 for amendment under the five-minute rule. It shall be in
8 order to consider as an original bill for the purpose of
9 amendment under the five-minute rule the amendment in
10 the nature of a substitute recommended by the Committee
11 on Education and Labor now printed in the bill. The com-
12 mittee amendment in the nature of a substitute shall be
13 considered as read. All points of order against the com-
14 mittee amendment in the nature of a substitute are waived
15 except those arising under clause 10 of rule XXI. Notwith-
16 standing clause 11 of rule XVIII, no amendment to the
17 committee amendment in the nature of a substitute shall
18 be in order except those printed in the report of the Com-
19 mittee on Rules accompanying this resolution. Each such
20 amendment may be offered only in the order printed in
21 the report, may be offered only by a Member designated
22 in the report, shall be considered as read, shall be debat-
23 able for the time specified in the report equally divided
24 and controlled by the proponent and an opponent, shall
25 not be subject to amendment, and shall not be subject to

1 a demand for division of the question in the House or in
2 the Committee of the Whole. All points of order against
3 such amendments are waived except those arising under
4 clause 9 or 10 of rule XXI. At the conclusion of consider-
5 ation of the bill for amendment the Committee shall rise
6 and report the bill to the House with such amendments
7 as may have been adopted. The previous question shall
8 be considered as ordered on the bill and amendments
9 thereto to final passage without intervening motion except
10 one motion to recommit with or without instructions.

11 SEC. 2. The Chair may entertain a motion that the
12 Committee rise only if offered by the chair of the Com-
13 mittee on Education and Labor or his designee. The Chair
14 may not entertain a motion to strike out the enacting
15 words of the bill (as described in clause 9 of rule XVIII).
