Providing for consideration of the resolution (H. Res. 826) expressing disapproval of the Trump administration's harmful actions towards Medicaid; providing for consideration of the bill (H.R. 2474) to amend the National Labor Relations Act, the Labor Management Relations Act, 1947, and the Labor-Management Reporting and Disclosure Act of 1959, and for other purposes; and providing for consideration of the bill (H.R. 5687) making emergency supplemental appropriations for the fiscal year ending September 30, 2020, and for other purposes.

Mr. DESAULNIER, from the Committee on Rules, reported the following resolution, which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the resolution (H. Res. 826) expressing disapproval of the Trump administration's harmful actions towards Medicaid; providing for consideration of the bill (H.R. 2474) to amend the National Labor Relations Act, the Labor Management Relations Act, 1947, and the Labor-Management Reporting and Disclosure Act of 1959, and for other purposes; and providing for consideration of the bill (H.R. 5687) mak-

ing emergency supplemental appropriations for the fiscal year ending September 30, 2020, and for other purposes.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order without intervention of any point of order
3 to consider in the House the resolution (H. Res. 826) ex-
4 pressing disapproval of the Trump administration's harm-
5 ful actions towards Medicaid. The resolution shall be con-
6 sidered as read. The previous question shall be considered
7 as ordered on the resolution and preamble to adoption
8 without intervening motion or demand for division of the
9 question except one hour of debate equally divided and
10 controlled by the chair and ranking minority member of
11 the Committee on Energy and Commerce.

12 SEC. 2. At any time after adoption of this resolution
13 the Speaker may, pursuant to clause 2(b) of rule XVIII,
14 declare the House resolved into the Committee of the
15 Whole House on the state of the Union for consideration
16 of the bill (H.R. 2474) to amend the National Labor Rela-
17 tions Act, the Labor Management Relations Act, 1947,
18 and the Labor-Management Reporting and Disclosure Act
19 of 1959, and for other purposes. The first reading of the
20 bill shall be dispensed with. All points of order against
21 consideration of the bill are waived. General debate shall
22 be confined to the bill and shall not exceed one hour equal-
23 ly divided and controlled by the chair and ranking minor-
24 ity member of the Committee on Education and Labor.

1 After general debate the bill shall be considered for
2 amendment under the five-minute rule. The amendment
3 in the nature of a substitute recommended by the Com-
4 mittee on Education and Labor now printed in the bill,
5 modified by the amendment printed in part A of the report
6 of the Committee on Rules accompanying this resolution,
7 shall be considered as adopted in the House and in the
8 Committee of the Whole. The bill, as amended, shall be
9 considered as the original bill for the purpose of further
10 amendment under the five-minute rule and shall be consid-
11 ered as read. All points of order against provisions in the
12 bill, as amended, are waived. No further amendment to
13 the bill, as amended, shall be in order except those printed
14 in part B of the report of the Committee on Rules. Each
15 such further amendment may be offered only in the order
16 printed in the report, may be offered only by a Member
17 designated in the report, shall be considered as read, shall
18 be debatable for the time specified in the report equally
19 divided and controlled by the proponent and an opponent,
20 shall not be subject to amendment, and shall not be sub-
21 ject to a demand for division of the question in the House
22 or in the Committee of the Whole. All points of order
23 against such further amendments are waived. At the con-
24 clusion of consideration of the bill for amendment the
25 Committee shall rise and report the bill, as amended, to

1 the House with such further amendments as may have
2 been adopted. The previous question shall be considered
3 as ordered on the bill, as amended, and on any further
4 amendment thereto to final passage without intervening
5 motion except one motion to recommit with or without in-
6 structions.

7 SEC. 3. At any time after adoption of this resolution
8 the Speaker may, pursuant to clause 2(b) of rule XVIII,
9 declare the House resolved into the Committee of the
10 Whole House on the state of the Union for consideration
11 of the bill (H.R. 5687) making emergency supplemental
12 appropriations for the fiscal year ending September 30,
13 2020, and for other purposes. The first reading of the bill
14 shall be dispensed with. All points of order against consid-
15 eration of the bill are waived. General debate shall be con-
16 fined to the bill and shall not exceed one hour equally di-
17 vided and controlled by the chair and ranking minority
18 member of the Committee on Appropriations. After gen-
19 eral debate the bill shall be considered for amendment
20 under the five-minute rule. The bill shall be considered
21 as read. All points of order against provisions in the bill
22 are waived. Clause 2(e) of rule XXI shall not apply during
23 consideration of the bill. No amendment to the bill shall
24 be in order except those printed in part C of the report
25 of the Committee on Rules accompanying this resolution.

1 Each such amendment may be offered only in the order
2 printed in the report, may be offered only by a Member
3 designated in the report, shall be considered as read, shall
4 be debatable for the time specified in the report equally
5 divided and controlled by the proponent and an opponent,
6 shall not be subject to amendment, and shall not be sub-
7 ject to a demand for division of the question in the House
8 or in the Committee of the Whole. All points of order
9 against such amendments are waived. At the conclusion
10 of consideration of the bill for amendment the Committee
11 shall rise and report the bill to the House with such
12 amendments as may have been adopted. The previous
13 question shall be considered as ordered on the bill and
14 amendments thereto to final passage without intervening
15 motion except one motion to recommit with or without in-
16 structions.
