Mr. COLLINS of Georgia, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 5711) to prohibit the Secretary of the Treasury from authorizing certain transactions by a U.S. financial institution in connection with the export or re-export of a commercial passenger aircraft to the Islamic Republic of Iran; providing for consideration of the bill (H.R. 5982) to amend chapter 8 of title 5, United States Code, to provide

for en bloc consideration in resolutions of disapproval for “midnight rules”, and for other purposes; and providing for proceedings during the period from November 18, 2016, through November 28, 2016.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the bill (H.R.
3 5711) to prohibit the Secretary of the Treasury from au-
4 thorizing certain transactions by a U.S. financial institu-
5 tion in connection with the export or re-export of a com-
6 mercial passenger aircraft to the Islamic Republic of Iran.
7 All points of order against consideration of the bill are
8 waived. In lieu of the amendment recommended by the
9 Committee on Financial Services now printed in the bill,
10 an amendment in the nature of a substitute consisting of
11 the text of Rules Committee Print 114-66 shall be consid-
12 ered as adopted. The bill, as amended, shall be considered
13 as read. All points of order against provisions in the bill,
14 as amended, are waived. The previous question shall be
15 considered as ordered on the bill, as amended, and on any
16 further amendment thereto, to final passage without inter-
17 vening motion except: (1) one hour of debate equally di-
18 vided and controlled by the chair and ranking minority
19 member of the Committee on Financial Services; (2) the
20 further amendment printed in part A of the report of the
21 Committee on Rules accompanying this resolution, if of-
22 fered by the Member designated in the report, which shall

1 be in order without intervention of any point of order,
2 shall be considered as read, shall be separately debatable
3 for the time specified in the report equally divided and
4 controlled by the proponent and an opponent, and shall
5 not be subject to a demand for a division of the question;
6 and (3) one motion to recommit with or without instruc-
7 tions.

8 SEC. 2. At any time after adoption of this resolution
9 the Speaker may, pursuant to clause 2(b) of rule XVIII,
10 declare the House resolved into the Committee of the
11 Whole House on the state of the Union for consideration
12 of the bill (H.R. 5982) to amend chapter 8 of title 5,
13 United States Code, to provide for en bloc consideration
14 in resolutions of disapproval for “midnight rules”, and for
15 other purposes. The first reading of the bill shall be dis-
16 pensed with. All points of order against consideration of
17 the bill are waived. General debate shall be confined to
18 the bill and shall not exceed one hour equally divided and
19 controlled by the chair and ranking minority member of
20 the Committee on the Judiciary. After general debate the
21 bill shall be considered for amendment under the five-
22 minute rule. The bill shall be considered as read. All points
23 of order against provisions in the bill are waived. No
24 amendment to the bill shall be in order except those print-
25 ed in part B of the report of the Committee on Rules ac-

1 accompanying this resolution. Each such amendment may
2 be offered only in the order printed in the report, may
3 be offered only by a Member designated in the report,
4 shall be considered as read, shall be debatable for the time
5 specified in the report equally divided and controlled by
6 the proponent and an opponent, shall not be subject to
7 amendment, and shall not be subject to a demand for divi-
8 sion of the question in the House or in the Committee
9 of the Whole. All points of order against such amendments
10 are waived. At the conclusion of consideration of the bill
11 for amendment the Committee shall rise and report the
12 bill to the House with such amendments as may have been
13 adopted. The previous question shall be considered as or-
14 dered on the bill and amendments thereto to final passage
15 without intervening motion except one motion to recommit
16 with or without instructions.

17 SEC. 3. On any legislative day during the period from
18 November 18, 2016, through November 28, 2016—

19 (a) the Journal of the proceedings of the previous day
20 shall be considered as approved; and

21 (b) the Chair may at any time declare the House ad-
22 journed to meet at a date and time, within the limits of
23 clause 4, section 5, article I of the Constitution, to be an-
24 nounced by the Chair in declaring the adjournment.

1 SEC. 4. The Speaker may appoint Members to per-
2 form the duties of the Chair for the duration of the period
3 addressed by section 3 of this resolution as though under
4 clause 8(a) of rule I.
