RESOLUTION

Providing for consideration of the bill (H.R. 4154) to amend the Internal Revenue Code of 1986 to repeal the new carryover basis rules in order to prevent tax increases and the imposition of compliance burdens on many more estates than would benefit from repeal, to retain the estate tax with a \$3,500,000 exemption, and for other purposes.

- 1 *Resolved*, That upon the adoption of this resolution
- 2 it shall be in order to consider in the House the bill (H.R.

1 4154) to amend the Internal Revenue Code of 1986 to
2 repeal the new carryover basis rules in order to prevent
3 tax increases and the imposition of compliance burdens
4 on many more estates than would benefit from repeal, to
5 retain the estate tax with a \$3,500,000 exemption, and
6 for other purposes. All points of order against consider-
7 ation of the bill are waived except those arising under
8 clause 9 or 10 of rule XXI. The bill shall be considered
9 as read. All points of order against provisions in the bill
10 are waived. The previous question shall be considered as
11 ordered on the bill to final passage without intervening
12 motion except: (1) one hour of debate equally divided and
13 controlled by the chair and ranking minority member of
14 the Committee on Ways and Means; and (2) one motion
15 to recommit.

16 SEC. 2. In the engrossment of H.R. 4154, the Clerk
17 shall—

18 (a) add the text of H.R. 2920, as passed by the
19 House, as new matter at the end of H.R. 4154;

20 (b) conform the title of H.R. 4154 to reflect the addi-
21 tion to the engrossment of the text of H.R. 2920;

22 (c) assign appropriate designations to provisions
23 within the engrossment; and

24 (d) conform provisions for short titles within the en-
25 grossment.
