## A BILL

To reform America's broken immigration system.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the "Immigration Reform  
5 that Works for America's Future Act".

6 **SEC. 2. SENSE OF THE SENATE.**

7 It is the sense of the Senate that Congress should—

8 (1) create a roadmap for immigrants who are  
9 here without legal status to earn citizenship, pro-

1 vided they pay taxes, complete a background check,  
2 learn English, and show a commitment to America;

3 (2) allow students who came to America as chil-  
4 dren to earn citizenship by attending college or join-  
5 ing the Armed Forces;

6 (3) protect the sustainability of the American  
7 agricultural industry, including the dairy industry,  
8 with a stable and legal agricultural workforce;

9 (4) encourage those who seek to invest in the  
10 United States and create American jobs;

11 (5) permit and encourage individuals who earn  
12 an advanced degree from one of our world-class uni-  
13 versities to remain in the United States, rather than  
14 using that education to work for our international  
15 competitors;

16 (6) fulfill and strengthen our Nation's commit-  
17 ments regarding security along our borders and at  
18 our ports of entry;

19 (7) strengthen our Nation's historic humani-  
20 tarian tradition of welcoming asylum seekers and  
21 refugees and improve existing policies that support  
22 immigrant victims of crime and domestic violence;

23 (8) create an effective electronic verification  
24 system and strengthen enforcement to prevent em-  
25 ployers from hiring people here illegally;

- 1           (9) implement a rational legal immigration sys-  
2           tem that promotes job creation by converting the  
3           current flow of illegal immigrants into the United  
4           States into a more manageable, controlled, and legal  
5           process for admitting immigrants while, at the same  
6           time, safeguarding the jobs, rights, and wages of  
7           American workers; and
- 8           (10) adopt practical and fair immigration re-  
9           forms to help ensure that all families are able to be  
10          together.
