To amend the Internal Revenue Code of 1986 to repeal the excise tax on telephone and other communications services.

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Telephone Excise Tax
- 5 Repeal Act of 2011".
- 6 SEC. 2. REPEAL OF EXCISE TAX ON TELEPHONE AND
- 7 OTHER COMMUNICATIONS SERVICES.
- 8 (a) In General.—Chapter 33 of the Internal Rev-
- 9 enue Code of 1986 is amended by striking subchapter B.
- 10 (b) Conforming Amendments.—
