# A BILL

- To direct the Attorney General to provide grants and access to information and resources for the implementation of the Sex Offender Registration Tips and Crime Victims Center Programs.
  - 1 Be it enacted by the Senate and House of Representa-
  - 2 tives of the United States of America in Congress assembled,

#### **3** SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Sex Offender Registra-

5 tion Tips Program Act of 2009" or the "SORT Act of

6 2009".

### 7 SEC. 2. FINDINGS.

8 Congress finds the following:

1 (1) Parents for Megan's Law, Inc., a nonprofit 2 corporation described in section 501(c)(3) of the Internal Revenue Code of 1986 and headquartered in 3 4 New York, has since 1998 educated and supported 5 the community, law enforcement, criminal justice, 6 and government agencies on issues related to sex of-7 fender registration, notification, responsible use of 8 information, sexual abuse and abduction prevention, 9 Internet Safety, and crime victim support.

10 (2) Parents for Megan's Law, Inc., established 11 and operates the National Megan's Law Helpline, a 12 free confidential telephone helpline that provides in-13 formation, support, and criminal justice referrals, 14 nationally and internationally, on sex offender man-15 agement issues. Parents for Megan's Law, Inc. is a 16 certified rape crisis center and provides support and 17 assistance to child and adult victims of sexual abuse 18 and all victims of violent crime. Research suggests 19 that sexual assault victims who receive counseling 20 support are more likely to report their attack to the 21 police and participate in the prosecution of the of-22 fender.

23 (3) The National Megan's Law Helpline has
24 generated over 70,000 requests for assistance, infor25 mation, or follow-up contacts on sex offender man-

1 agement, crime victim support, and prevention edu-2 cation issues. Helpline requests utilize the Helpline's resources and often entail coordination with outside 3 4 resources, follow-up calls, or actual referrals to any 5 or all of the following: law enforcement and other 6 criminal justice agencies, state and local crime vic-7 tims assistance agencies and organizations, social 8 service and human service providers, and other serv-9 ice provider organizations.

10 The Internet website (4)of Parents for 11 Megan's Law, Inc., serves as a clearinghouse and 12 national resource for information related to sex of-13 fender registration, notification, sexual abuse and 14 abduction prevention, and crime victims' support 15 and referrals. Such Internet website is also utilized 16 by the public to anonymously report Internet child 17 pornography and child sex tourism and as a resource 18 for Internet Safety education. Reports are forwarded 19 to local law enforcement for appropriate follow-up.

20 (5)(A) With limited resources, the National
21 Megan's Law Helpline has provided the public with
22 a resource for confidentially reporting registered sex
23 offenders failing to comply with registration require24 ments, supervision, or employment restrictions or
25 who are in positions of trust where potential child

| 10 | a registered child day care center where he           |
| 11 | could access potential child victims;                 |
| 12 | (ii) preventing a convicted former middle             |
| 13 | school teacher required to register as a sex of-      |
| 14 | fender and give up his teacher's license, from        |
| 15 | gaining employment as an in home children's           |
| 16 | tutor for a reputable tutoring company where          |
| 17 | he could gain unsupervised access to potential        |
| 18 | child victims;  |
| 19 | (iii) having a registered sex offender who            |
| 20 | targeted a child, and subsequently was barred         |
| 21 | from using the Internet to develop online rela-       |
| 22 | tionships, removed from an Internet Dating            |

| 14 | (6) A national Sex Offender Registration Com-         |
| 15 | pliance survey conducted by Parents for Megan's       |
| 16 | Law, Inc., in 2003, indicated that, 24 percent of (or |
| 17 | over 100,000) registered sex offenders were not com-  |
| 18 | plying with sex offender registration laws. Sex of-   |
| 19 | fender registry information provides parents and      |
| 20 | community members an opportunity to protect them-     |
| 21 | selves, their children, and their communities from    |
| 22 | sexual victimization, but that information, in order  |
| 23 | to be of value, requires labor intensive follow-up    |
| 24 | intervention and proactive maintenance to be kept     |
| 25 | current.  |

(i) about registered sex offenders who 1 2 are believed to be out of compliance with 3 registration requirements, supervision, or 4 employment restrictions and who are in positions of trust where potential child vic-5 6 tims can be accessed; or 7 (ii) concerning sex offender activities 8 that indicate a heightened risk of re-of-9 fending. 10 (10)(A) The SORT program will serve as a 11 powerful national tool supporting communities and 12 crime victims while assisting and advancing the mis-13 sion of Federal, state, and local law enforcement in 14 combating sexual victimization. 15 (B) The SORT program and the National 16 Megan's Law Helpline is unique in the following 17 ways: 18 (i) It provides up to date sexual abuse pre-19 vention information, deters vigilantism, and re-20 inforces responsible use of information. 21 (ii) It provides victims who come forth with 22 needed information with an infrastructure of 23 advocacy, enforcement, and therapeutic support. 24 (iii) It maximizes law enforcement's al-

| 5  | <b>REGISTRATION TIPS PROGRAM.</b>                         |
| 6  | (a) IN GENERAL.—Subject to the availability of the        |
| 7  | funds authorized to be appropriated under subsection (d), |
| 8  | the Attorney General shall provide grants and access to   |
| 9  | information and resources to the not-for-profit community |
| 10 | and victim's rights organization, Parents for Megan's     |
| 11 | Law, Inc., to implement the Sex Offender Registration     |
| 12 | Tips Program described in subsection (b).                 |

| 14 | Described.—For purposes of subsection (a), the Sex Of-    |

register in the sex offender registry maintained by
 the jurisdiction involved or who engage in activities
 in violation of conditions of their probation or parole
 or other criminal activities;

(3) using existing Internet sex offender reg-5 6 istries, public information, and the National Crimi-7 nal Information databases to compare and contrast 8 information and proactively identify high-risk reg-9 istrants who are out of compliance, in violation of 10 conditions of supervision, and identify the location of 11 wanted registrants in order to ascertain the need for 12 follow-up action by law enforcement;

13 (4) providing crime victims support, informa-14 tion, and referrals; and

(5) supporting community members with up-todate sex offender registration, notification, and sexual abuse and abduction prevention and Internet
Safety information.

(c) ACCESS.—Notwithstanding any other provision of
law, the Attorney General shall ensure access by Parents
for Megan's Law, Inc., to the National Crime Information
Center databases operated by the Federal Bureau of Investigation pursuant to section 534 of title 28, United
States Code, to the extent that such access is only for purposes within the scope of the organization's duties and re-

sponsibilities to assist or support law enforcement agencies
 in administration of criminal justice functions.

3 (d) AUTHORIZATION OF APPROPRIATIONS.—There is
4 authorized to be appropriated \$1,000,000 for grants
5 under subsection (a) for each of the fiscal years 2010
6 through 2014.
