3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Equal Access to Tax

5 Planning Act".

6 SEC. 2. TAX STRATEGIES DEEMED WITHIN THE PRIOR ART.

7 (a) IN GENERAL.—For purposes of evaluating an in-

8 vention under section 102 or 103 of title 35, United States

9 Code, any strategy for reducing, avoiding, or deferring tax

liability, whether known or unknown at the time of the
invention or application for patent, shall be deemed insuf ficient to differentiate a claimed invention from the prior
art.

(b) DEFINITION.—For purposes of this section, the 5 term "tax liability" refers to any liability for a tax under 6 7 any Federal, State, or local law, or the law of any foreign jurisdiction, including any statute, rule, regulation, or or-8 dinance that levies, imposes, or assesses such tax liability. 9 10 (c) EFFECTIVE DATE; APPLICABILITY.—This section 11 shall take effect on the date of enactment of this Act and 12 shall apply to any patent application pending and any patent issued on or after that date. 13
