A BILL

To prohibit direct foreign assistance to the Government of Egypt until the President makes certain certifications related to treatment of nongovernmental organization workers, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. PROHIBITION ON FOREIGN ASSISTANCE TO**
4 **EGYPT.**

5 (a) PROHIBITION.—No amounts may be obligated or
6 expended to provide any direct United States assistance

1 to the Government of Egypt unless the President certifies
2 to Congress that—

3 (1) the Government of Egypt is not holding, de-
4 taining, prosecuting, harassing, or preventing the
5 exit from Egypt of any person working for a non-
6 governmental organization supported by the United
7 States Government on the basis of the person's asso-
8 ciation with or work for the nongovernmental orga-
9 nization;

10 (2) the Government of Egypt is not holding any
11 property of a nongovernmental organization de-
12 scribed in paragraph (1) or of a person associated
13 with such a nongovernmental organization; and

14 (3) the Government of Egypt—

15 (A) has dropped all charges against the
16 persons described in paragraph (1);

17 (B) is no longer seeking the arrest of such
18 persons; and

19 (C) is no longer seeking the extradition of
20 such persons to Egypt for trial.

21 (b) RESCISSION OF FUNDS.—

22 (1) IN GENERAL.—Subject to paragraph (2), of
23 any amounts previously appropriated for direct
24 United States assistance to the Government of
25 Egypt and available for obligation as of the date of

1 the enactment of this Act, \$5,000,000 is hereby re-
2 scinded.

3 (2) CERTIFICATION.—If the President certifies
4 to Congress the total amount of funds paid by the
5 United States Government, nongovernmental organi-
6 zations supported by the United States Government,
7 and individuals working for such nongovernmental
8 organizations to obtain the release of persons work-
9 ing for nongovernmental organizations detained by
10 the Government of Egypt, the amount rescinded
11 under paragraph (1) shall instead be the amount so
12 certified.

13 (3) INSUFFICIENT FUNDS.—If the President
14 certifies to Congress that the amount of funds re-
15 quired to be rescinded under paragraph (1) or para-
16 graph (2) is greater than the amount of funds avail-
17 able to be rescinded, the President shall withhold
18 from future funding available for direct United
19 States assistance to the Government of Egypt an
20 amount equal to the difference between the amount
21 required to be rescinded and the amount available to
22 be rescinded and transfer such amount to the Treas-
23 ury of the United States to be used for deficit reduc-
24 tion.
