**A BILL**

To amend title XII of the Public Health Service Act to reauthorize certain trauma care programs, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Trauma Systems and  
5 Regionalization of Emergency Care Reauthorization Act”.

1 **SEC. 2. REAUTHORIZATION OF CERTAIN TRAUMA CARE**  
2 **PROGRAMS.**

3 Section 1232(a) of the Public Health Service Act (42  
4 U.S.C. 300d–32(a)) is amended by striking “2014” and  
5 inserting “2019”.

6 **SEC. 3. IMPROVEMENTS AND CLARIFICATIONS TO CERTAIN**  
7 **TRAUMA CARE PROGRAMS.**

8 (a) ALLOCATION OF FUNDS FOR COMPETITIVE  
9 GRANTS FOR REGIONALIZED SYSTEMS FOR EMERGENCY  
10 CARE RESPONSE.—Section 1232(c) of the Public Health  
11 Service Act (42 U.S.C. 300d–32(c)) is amended—

12 (1) in paragraph (1), by striking “and” at the  
13 end;

14 (2) in paragraph (2), by striking the period at  
15 the end and inserting “; and”; and

16 (3) by adding at the end the following new  
17 paragraph:

18 “(3) for a fiscal year after fiscal year 2014, not  
19 more than 50 percent of such amounts remaining  
20 for such fiscal year after application of paragraphs  
21 (1) and (2) shall be allocated for the purpose of car-  
22 rying out section 1204.”.

23 (b) CLARIFICATIONS UNDER TRAUMA SYSTEMS FOR-  
24 MULA GRANTS REQUIREMENTS RELATING TO THE AMER-  
25 ICAN BURN ASSOCIATION.—Section 1213 of the Public  
26 Health Service Act (42 U.S.C. 300d–13) is amended—

1           (1) in subsection (a)(3), by inserting “and (for  
2           a fiscal year after fiscal year 2014) contains national  
3           standards and requirements of the American Burn  
4           Association for the designation of verified burn cen-  
5           ters,” after “such entity,”;

6           (2) in subsection (b)(3)(A), by striking “and  
7           the American Academy of Pediatrics,” and inserting  
8           “the American Academy of Pediatrics, and (for a  
9           fiscal year after fiscal year 2014) the American  
10          Burn Association,”; and

11          (3) in subsection (c)(1)—

12                (A) in the matter preceding subparagraph  
13                (A), by inserting “and not later than 1 year  
14                after the date of the enactment of the Trauma  
15                Systems and Regionalization of Emergency  
16                Care Reauthorization Act” after “Act of 2007”;  
17                and

18                (B) in subparagraph (A), by striking “and  
19                the American Academy of Pediatrics” and in-  
20                serting “the American Academy of Pediatrics,  
21                and (with respect to the update pursuant to the  
22                Trauma Systems and Regionalization of Emer-  
23                gency Care Reauthorization Act) the American  
24                Burn Association”.

1           (c) TECHNICAL AMENDMENTS.—Part B of title XII  
2 of the Public Health Service Act is amended—

3           (1) in section 1218(c)(2) (42 U.S.C. 300d–  
4 18(c)(2)), in the matter preceding subparagraph  
5 (A), by striking “1232(b)(3)” and inserting “section  
6 1232(b)”; and

7           (2) in section 1222 (42 U.S.C. 300d–22), by  
8 striking “October 1, 2008” and inserting “October  
9 1, 2016”.
