3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Dairy Farm Sustain-

5 ability Act of 2018".

6 SEC. 2. DAIRY FARM SUSTAINABILITY PRICE LOSS COV-7 ERAGE PROGRAM.

8 Part I of subtitle D of title I of the Agricultural Act
9 of 2014 is amended by inserting after section 1408 (7
10 U.S.C. 9058) the following:

1	"SEC. 1408A. DAIRY FARM SUSTAINABILITY PRICE LOSS
2	COVERAGE PROGRAM.
3	"(a) DEFINITIONS.—In this section:
4	"(1) CONTRACTING DAIRY OPERATION.—The
5	term 'contracting dairy operation' means a partici-
6	pating dairy operation that enters into a contract
7	under subsection (b)(1).
8	"(2) MINIMUM MILK PRICE.—The term 'min-
9	imum milk price' means \$23.34 per hundredweight
10	of milk, as adjusted by the Secretary for each half
11	of each calendar year to reflect changes in the Con-
12	sumer Price Index for All Urban Consumers pub-
13	lished by the Bureau of Labor Statistics of the De-
14	partment of Labor.
15	"(3) PAYMENT QUANTITY.—The term 'payment
16	quantity' means the payment quantity established
17	for a contracting dairy operation under subsection
18	(c)(3).
19	"(b) Contracts.—
20	"(1) IN GENERAL.—The Secretary shall offer to
21	enter into a contract with a participating dairy oper-
22	ation under which the participating dairy operation
23	may receive payments under subsection (c).
24	"(2) SIGNUP.—The Secretary shall offer to
25	enter into contracts under paragraph (1) during the
26	period that a dairy operation may register to partici-

1	pate in the margin protection program established
2	under section 1404(b).
3	"(3) DURATION OF CONTRACTS.—
4	"(A) IN GENERAL.—Except as provided in
5	subparagraph (B), a contract entered into
6	under paragraph (1) shall cover milk marketed
7	by the contracting dairy operation during the
8	period beginning on the first day of the month
9	during which the contract is entered into and
10	ending on December 31, 2023.
11	"(B) VIOLATIONS.—If a contracting dairy
12	operation violates a contract entered into under
13	paragraph (1), the Secretary may—
14	"(i) terminate the contract and allow
15	the contracting dairy operation to retain
16	any payments received under the contract;
17	or
18	"(ii) allow the contract to remain in
19	effect and require the contracting dairy op-
20	eration to repay a portion of the payments
21	received under the contract, based on the
22	severity of the violation.
23	"(c) PAYMENTS.—
24	"(1) IN GENERAL.—The Secretary shall provide
25	to a contracting dairy operation a payment for a

1	month under this subsection and not under the mar-
2	gin protection program if the amount of the pay-
3	ment to the contracting dairy operation for that
4	month under this section is greater than the amount
5	that the contracting dairy operation would receive
6	under the margin protection program.
7	"(2) Amount.—The amount of a payment to a
8	contracting dairy operation under this subsection
9	shall be equal to the product obtained by multi-
10	plying, as determined by the Secretary—
11	"(A) the payment quantity during the ap-
12	plicable month;
13	"(B) the difference obtained by sub-
14	tracting—
15	"(i) the minimum milk price; and
16	"(ii) the 'All Milk' price per hundred-
17	weight under the applicable Federal milk
18	marketing order; and
19	"(C) 45 percent.
20	"(3) PAYMENT QUANTITY.—
21	"(A) IN GENERAL.—Subject to subpara-
22	graph (B), the payment quantity for a con-
23	tracting dairy operation for a month shall be
24	equal to the hundredweight of milk marketed by

1	the contracting dairy operation during the
2	month.
3	"(B) LIMITATION.—The payment quantity
4	described in subparagraph (A) for any month
5	for a contracting dairy operation shall not ex-
6	ceed 4,166 hundredweight of milk.
7	"(4) TIMING OF PAYMENTS.—The Secretary
8	shall make a payment to a contracting dairy oper-
9	ation under this subsection not later than 60 days
10	after the last day of the month for which the pay-
11	ment is made.".
12	SEC. 3. EXTENSION OF MARGIN PROTECTION PROGRAM
13	FOR DAIRY PRODUCERS.
14	Section 1409 of the Agricultural Act of 2014 (7
15	U.S.C. 9059) is amended by striking "2018" and insert-
16	ing "2023".
