A BILL

To improve the Junior Reserve Officers' Training Corps programs, to authorize an expansion of their presence in low-income, rural, and underserved areas of the United States, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "JROTC Opportunities
- 5 for Transformational Change Act" or "JROTC Act".

1	SEC. 2. ENHANCEMENT OF AUTHORITIES IN CONNECTION
2	WITH JUNIOR RESERVE OFFICERS' TRAINING
3	CORPS PROGRAMS.
4	(a) Authority To Convert Otherwise Closing
5	Units to National Defense Cadet Corps Program
6	UNITS.—If the Secretary of a military department is noti-
7	fied by a local educational agency of the intent of the
8	agency to close its Junior Reserve Officers' Training
9	Corps (JROTC) unit, the Secretary shall offer the agency
10	the option of converting the program to a National De-
11	fense Cadet Corps (NDCC) program unit in lieu of closing
12	the unit.
13	(b) Flexibility in Administration of Instruc-
14	TORS.—
15	(1) In general.—The Secretaries of the mili-
16	tary departments shall undertake initiatives designed
17	to promote flexibility in the hiring and compensation
18	of instructors for the Junior Reserve Officers' Train-
19	ing Corps program under the jurisdiction of such
20	Secretaries.
21	(2) Elements.—The initiatives undertaken
22	pursuant to this subsection may provide for one or
23	more of the following:
24	(A) Termination of the requirement for a
25	waiver as a condition of the hiring of well-quali-
26	fied non-commissioned officers with a bachelor's

- degree for senior instructor positions within the Junior Reserve Officers' Training Corps.
 - (B) Specification of a single instructor as the minimum number of instructors required to found and operate a Junior Reserve Officers' Training Corps unit.
 - (C) Authority for Junior Reserve Officers' Training Corps instructors to undertake school duties, in addition to Junior Reserve Officers' Training Corps duties, at small schools.
 - (D) Authority for the payment of instructor compensation for a limited number of Junior Reserve Officers' Training Corps instructors on a 10-month per year basis rather than a 12month per year basis.
 - (E) Such other actions as the Secretaries of the military departments consider appropriate.
- 19 (c) FLEXIBILITY IN ALLOCATION AND USE OF TRAV20 EL FUNDING.—The Secretaries of the military depart21 ments shall take appropriate actions to provide so-called
 22 regional directors of the Junior Reserve Officers' Training
 23 Corps programs located at remote rural schools enhanced
 24 discretion in the allocation and use of funds for travel in

- 3 (d) Standardization of Program Data.—The
- 4 Secretary of Defense shall take appropriate actions to
- 5 standardize the data collected and maintained on the Jun-
- 6 ior Reserve Officers' Training Corps programs in order
- 7 to facilitate and enhance the collection and analysis of
- 8 such data. Such actions shall include a requirement for
- 9 the use of the National Center for Education Statistics
- 10 (NCES) identification code for each school with a unit
- 11 under a Junior Reserve Officers' Training Corps program
- 12 in order to facilitate identification of such schools and
- 13 their units under the Junior Reserve Officers' Training
- 14 Corps programs.
- 15 (e) AUTHORITY FOR ADDITIONAL UNITS.—
- 16 (1) In General.—The Secretaries of the mili-
- tary departments may, using amounts authorized to
- be appropriated by paragraph (2), establish an ag-
- 19 gregate of not more than 100 units under the Junior
- 20 Reserve Officers' Training Corps programs in low-
- 21 income and rural areas of the United States and
- areas of the United States currently underserved by
- 23 the Junior Reserve Officers' Training Corps pro-
- 24 grams.

1	(2) Funding.—There is hereby authorized to
2	be appropriated for fiscal year 2019 for the Depart-
3	ment of Defense amounts as follows:
4	(A) For Operation and Maintenance,
5	Army, \$3,140,000, with the amount available
6	for the Junior Reserve Officers' Training Corps
7	program of the Army.
8	(B) For Operation and Maintenance,
9	Navy, \$950,000, with the amount available for
10	the Junior Reserve Officers' Training Corps
11	program of the Navy.
12	(C) For Operation and Maintenance, Air
13	Force, \$1,000,000, with the amount available
14	for the Junior Reserve Officers' Training Corps
15	program of the Air Force.
16	(D) For Operation and Maintenance, Ma-
17	rine Corps, \$390,000, with the amount avail-
18	able for the Junior Reserve Officers' Training
19	Corps program of the Marine Corps.
20	(E) For Military Personnel, \$1,220,000, of
21	which—
22	(i) \$500,000 is for the Army for the
23	Junior Reserve Officers' Training Corps
24	program of the Army;

1	(ii) \$270,000 is for the Navy for the
2	Junior Reserve Officers' Training Corps
3	program of the Navy;
4	(iii) \$380,000 is for the Air Force for
5	the Junior Reserve Officers' Training
6	Corps program of the Air Force; and
7	(iv) \$70,000 is for the Marine Corps
8	for the Junior Reserve Officers' Training
9	Corps program of the Marine Corps.
10	(3) Supplement not supplant.—The
11	amounts authorized to be appropriated for fiscal
12	year 2019 for the Department of Defense by this
13	subsection are in addition to any other amounts au-
14	thorized to be appropriated for fiscal year 2019 for
15	the Department under any other provision of law.
