Mr. BLUMENTHAL (for himself, Mr. TOOMEY, and Mr. MURPHY) introduced the following bill; which was read twice and referred to the Committee on the Judiciary

A BILL

To amend the Omnibus Crime Control and Safe Streets Act of 1968 to extend public safety officers' death benefits to fire police officers.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Fire Police Fairness
5 Act”.

1 **SEC. 2. EXTENDING PUBLIC SAFETY OFFICER DEATH BENE-**
2 **FITS TO FIRE POLICE.**

3 (a) IN GENERAL.—Section 1204 of title I the Omni-
4 bus Crime Control and Safe Streets Act of 1968 (34
5 U.S.C. 10284) is amended—

6 (1) by redesignating paragraphs (5) through
7 (9) as paragraphs (6) through (10), respectively;

8 (2) by inserting after paragraph (4) the fol-
9 lowing new paragraph:

10 “(5) ‘fire police officer’ includes an individual
11 who—

12 “(A) is serving in accordance with State or
13 local law as an officially recognized or des-
14 ignated member of a legally organized public
15 safety agency but is not a law enforcement offi-
16 cer, a firefighter, a chaplain, or a member of a
17 rescue squad or ambulance crew described in
18 paragraph (10)(D); and

19 “(B) provides scene security or directs
20 traffic—

21 “(i) in response to any fire drill, fire
22 call, or other fire, rescue, or police emer-
23 gency; or

24 “(ii) at a planned special event;” and

1 (3) in paragraph (10)(A), as so redesignated,
2 by inserting “as a fire police officer,” after “fire-
3 fighter,”.

4 (b) TECHNICAL AND CONFORMING AMENDMENT.—
5 Section 611(a) of the Uniting and Strengthening America
6 by Providing Appropriate Tools Required to Intercept and
7 Obstruct Terrorism Act of 2001 (34 U.S.C. 10286(a)) is
8 amended—

9 (1) by striking “section 1204(7)(B)” and in-
10 serting “section 1204(8)(B) of title I”; and

11 (2) by striking “(42 U.S.C. 3796b(7)(B))” and
12 inserting “(34 U.S.C. 10284(8)(B))”.
