## A BILL

To reauthorize certain National Heritage Areas, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “National Heritage  
5 Areas Reauthorization Act of 2019”.

1 **SEC. 2. AUTHORIZATION OF APPROPRIATIONS FOR THE**  
2 **LAST GREEN VALLEY NATIONAL HERITAGE**  
3 **CORRIDOR AND THE ERIE CANALWAY NA-**  
4 **TIONAL HERITAGE CORRIDOR.**

5 (a) AUTHORIZATION OF APPROPRIATIONS FOR THE  
6 LAST GREEN VALLEY NATIONAL HERITAGE COR-  
7 RIDOR.—Section 109(a) of the Quinebaug and Shetucket  
8 Rivers Valley National Heritage Corridor Act of 1994 (54  
9 U.S.C. 320101 note; Public Law 103–449; 108 Stat.  
10 4756; 113 Stat. 1729; 123 Stat. 1292) is amended by  
11 striking “\$15,000,000” and inserting “\$17,000,000”.

12 (b) AUTHORIZATION OF APPROPRIATIONS FOR THE  
13 ERIE CANALWAY NATIONAL HERITAGE CORRIDOR.—Sec-  
14 tion 810(a)(1) of the Erie Canalway National Heritage  
15 Corridor Act (54 U.S.C. 320101 note; Public Law 106–  
16 554; 114 Stat. 2763A–303; 131 Stat. 461) is amended  
17 by striking “\$12,000,000” and inserting “\$14,000,000”.

18 **SEC. 3. REAUTHORIZATION OF NATIONAL AVIATION HERIT-**  
19 **AGE AREA AND THE OIL REGION NATIONAL**  
20 **HERITAGE AREA.**

21 (a) REAUTHORIZATION OF THE NATIONAL AVIATION  
22 HERITAGE AREA.—Section 512 of the National Aviation  
23 Heritage Area Act (54 U.S.C. 320101 note; Public Law  
24 108–447; 118 Stat. 3367) is amended by striking “on the  
25 date that is 15 years after the date that funds are first

1 made available for this title” and inserting “on October  
2 1, 2022”.

3 (b) REAUTHORIZATION OF THE OIL REGION NA-  
4 TIONAL HERITAGE AREA.—Section 608 of the Oil Region  
5 National Heritage Area Act (54 U.S.C. 320101 note; Pub-  
6 lic Law 108–447; 118 Stat. 3372) is amended by striking  
7 “the expiration of the 15-year period beginning on the  
8 date that funds are first made available for this title” and  
9 inserting “September 30, 2022”.
