A BILL

Making appropriations for the Department of the Interior, environment, and related agencies for the fiscal year ending September 30, 2019, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 That the following sums are appropriated, out of any
- 4 money in the Treasury not otherwise appropriated, for the
- 5 Department of the Interior, environment, and related
- 6 agencies for the fiscal year ending September 30, 2019,
- 7 and for other purposes, namely:

2	DEPARTMENT OF THE INTERIOR
3	Bureau of Land Management
4	MANAGEMENT OF LANDS AND RESOURCES
5	For necessary expenses for protection, use, improve-
6	ment, development, disposal, cadastral surveying, classi-
7	fication, acquisition of easements and other interests in
8	lands, and performance of other functions, including main-
9	tenance of facilities, as authorized by law, in the manage-
10	ment of lands and their resources under the jurisdiction
11	of the Bureau of Land Management, including the general
12	administration of the Bureau, and assessment of mineral
13	potential of public lands pursuant to section 1010(a) of
14	Public Law 96–487 (16 U.S.C. 3150(a)), \$1,196,143,000,
15	to remain available until expended, including all such
16	amounts as are collected from permit processing fees, as
17	authorized but made subject to future appropriation by
18	section $35(d)(3)(A)(i)$ of the Mineral Leasing Act (30
19	U.S.C. 191), except that amounts from permit processing
20	fees may be used for any bureau-related expenses associ-
21	ated with the processing of oil and gas applications for
22	permits to drill and related use of authorizations.
23	In addition, \$39,696,000 is for Mining Law Adminis-
24	tration program operations, including the cost of admin-
25	istering the mining claim fee program, to remain available

- 1 until expended, to be reduced by amounts collected by the
- 2 Bureau and credited to this appropriation from mining
- 3 claim maintenance fees and location fees that are hereby
- 4 authorized for fiscal year 2019, so as to result in a final
- 5 appropriation estimated at not more than \$1,196,143,000,
- 6 and \$2,000,000, to remain available until expended, from
- 7 communication site rental fees established by the Bureau
- 8 for the cost of administering communication site activities.

9 LAND ACQUISITION

- For expenses necessary to carry out sections 205,
- 11 206, and 318(d) of Public Law 94-579, including admin-
- 12 istrative expenses and acquisition of lands or waters, or
- 13 interests therein, \$26,016,000, to be derived from the
- 14 Land and Water Conservation Fund and to remain avail-
- 15 able until expended.

16 OREGON AND CALIFORNIA GRANT LANDS

- 17 For expenses necessary for management, protection,
- 18 and development of resources and for construction, oper-
- 19 ation, and maintenance of access roads, reforestation, and
- 20 other improvements on the revested Oregon and California
- 21 Railroad grant lands, on other Federal lands in the Or-
- 22 egon and California land-grant counties of Oregon, and
- 23 on adjacent rights-of-way; and acquisition of lands or in-
- 24 terests therein, including existing connecting roads on or
- 25 adjacent to such grant lands; \$106,543,000, to remain

- 1 available until expended: *Provided*, That 25 percent of the
- 2 aggregate of all receipts during the current fiscal year
- 3 from the revested Oregon and California Railroad grant
- 4 lands is hereby made a charge against the Oregon and
- 5 California land-grant fund and shall be transferred to the
- 6 General Fund in the Treasury in accordance with the sec-
- 7 ond paragraph of subsection (b) of title II of the Act of
- 8 August 28, 1937 (43 U.S.C. 2605).

9 RANGE IMPROVEMENTS

- 10 For rehabilitation, protection, and acquisition of
- 11 lands and interests therein, and improvement of Federal
- 12 rangelands pursuant to section 401 of the Federal Land
- 13 Policy and Management Act of 1976 (43 U.S.C. 1751),
- 14 notwithstanding any other Act, sums equal to 50 percent
- 15 of all moneys received during the prior fiscal year under
- 16 sections 3 and 15 of the Taylor Grazing Act (43 U.S.C.
- 17 315b, 315m) and the amount designated for range im-
- 18 provements from grazing fees and mineral leasing receipts
- 19 from Bankhead-Jones lands transferred to the Depart-
- 20 ment of the Interior pursuant to law, but not less than
- 21 \$10,000,000, to remain available until expended: Pro-
- 22 vided, That not to exceed \$600,000 shall be available for
- 23 administrative expenses.

1	SERVICE	CHARGES.	DEPOSITS.	AND	FORFEITURES

- 2 For administrative expenses and other costs related
- 3 to processing application documents and other authoriza-
- 4 tions for use and disposal of public lands and resources,
- 5 for costs of providing copies of official public land docu-
- 6 ments, for monitoring construction, operation, and termi-
- 7 nation of facilities in conjunction with use authorizations,
- 8 and for rehabilitation of damaged property, such amounts
- 9 as may be collected under Public Law 94–579 (43 U.S.C.
- 10 1701 et seq.), and under section 28 of the Mineral Leasing
- 11 Act (30 U.S.C. 185), to remain available until expended:
- 12 Provided, That notwithstanding any provision to the con-
- 13 trary of section 305(a) of Public Law 94–579 (43 U.S.C.
- 14 1735(a)), any moneys that have been or will be received
- 15 pursuant to that section, whether as a result of forfeiture,
- 16 compromise, or settlement, if not appropriate for refund
- 17 pursuant to section 305(c) of that Act (43 U.S.C.
- 18 1735(c)), shall be available and may be expended under
- 19 the authority of this Act by the Secretary to improve, pro-
- 20 tect, or rehabilitate any public lands administered through
- 21 the Bureau of Land Management which have been dam-
- 22 aged by the action of a resource developer, purchaser, per-
- 23 mittee, or any unauthorized person, without regard to
- 24 whether all moneys collected from each such action are
- 25 used on the exact lands damaged which led to the action:

- 1 Provided further, That any such moneys that are in excess
- 2 of amounts needed to repair damage to the exact land for
- 3 which funds were collected may be used to repair other
- 4 damaged public lands.

5 MISCELLANEOUS TRUST FUNDS

- 6 In addition to amounts authorized to be expended
- 7 under existing laws, there is hereby appropriated such
- 8 amounts as may be contributed under section 307 of Pub-
- 9 lie Law 94–579 (43 U.S.C. 1737), and such amounts as
- 10 may be advanced for administrative costs, surveys, ap-
- 11 praisals, and costs of making conveyances of omitted lands
- 12 under section 211(b) of that Act (43 U.S.C. 1721(b)), to

- 15 The Bureau of Land Management may carry out the
- 16 operations funded under this Act by direct expenditure,

- 19 with States. Appropriations for the Bureau shall be avail-
- 20 able for purchase, erection, and dismantlement of tem-
- 21 porary structures, and alteration and maintenance of nec-
- 22 essary buildings and appurtenant facilities to which the
- 23 United States has title; up to \$100,000 for payments, at
- 24 the discretion of the Secretary, for information or evidence
- 25 concerning violations of laws administered by the Bureau;

- 1 miscellaneous and emergency expenses of enforcement ac-
- 2 tivities authorized or approved by the Secretary and to be
- 3 accounted for solely on the Secretary's certificate, not to
- 4 exceed \$10,000: Provided, That notwithstanding Public
- 5 Law 90–620 (44 U.S.C. 501), the Bureau may, under co-
- 6 operative cost-sharing and partnership arrangements au-
- 7 thorized by law, procure printing services from cooperators
- 8 in connection with jointly produced publications for which
- 9 the cooperators share the cost of printing either in cash
- 10 or in services, and the Bureau determines the cooperator
- 11 is capable of meeting accepted quality standards: Provided
- 12 further, That projects to be funded pursuant to a written
- 13 commitment by a State government to provide an identi-
- 14 fied amount of money in support of the project may be
- 15 carried out by the Bureau on a reimbursable basis. Appro-
- 16 priations herein made shall not be available for the de-
- 17 struction of healthy, unadopted, wild horses and burros
- 18 in the care of the Bureau or its contractors or for the
- 19 sale of wild horses and burros that results in their destruc-
- 20 tion for processing into commercial products.
- 21 UNITED STATES FISH AND WILDLIFE SERVICE
- 22 RESOURCE MANAGEMENT
- For necessary expenses of the United States Fish and
- 24 Wildlife Service, as authorized by law, and for scientific
- 25 and economic studies, general administration, and for the

- 1 performance of other authorized functions related to such
- 2 resources, \$1,292,067,000, to remain available until Sep-
- 3 tember 30, 2020: Provided, That not to exceed
- 4 \$17,818,000 shall be used for implementing subsections
- 5 (a), (b), (c), and (e) of section 4 of the Endangered Spe-
- 6 cies Act of 1973 (16 U.S.C. 1533) (except for processing
- 7 petitions, developing and issuing proposed and final regu-
- 8 lations, and taking any other steps to implement actions
- 9 described in subsection (c)(2)(A), (c)(2)(B)(i), or
- 10 (c)(2)(B)(ii).
- 11 CONSTRUCTION
- For construction, improvement, acquisition, or re-
- 13 moval of buildings and other facilities required in the con-
- 14 servation, management, investigation, protection, and uti-
- 15 lization of fish and wildlife resources, and the acquisition
- 16 of lands and interests therein; \$50,413,000, to remain
- 17 available until expended.
- 18 LAND ACQUISITION
- For expenses necessary to carry out chapter 2003 of
- 20 title 54, United States Code, including administrative ex-
- 21 penses, and for acquisition of land or waters, or interest
- 22 therein, in accordance with statutory authority applicable
- 23 to the United States Fish and Wildlife Service,
- 24 \$45,189,000, to be derived from the Land and Water Con-
- 25 servation Fund and to remain available until expended:

- 1 Provided, That none of the funds appropriated for specific
- 2 land acquisition projects may be used to pay for any ad-
- 3 ministrative overhead, planning or other management
- 4 costs.
- 5 COOPERATIVE ENDANGERED SPECIES CONSERVATION
- 6 FUND
- 7 For expenses necessary to carry out section 6 of the
- 8 Endangered Species Act of 1973 (16 U.S.C. 1535),
- 9 \$49,495,000, to remain available until expended, of which
- 10 \$18,695,000 is to be derived from the Cooperative Endan-
- 11 gered Species Conservation Fund; and of which
- 12 \$30,800,000 is to be derived from the Land and Water
- 13 Conservation Fund.
- 14 NATIONAL WILDLIFE REFUGE FUND
- 15 For expenses necessary to implement the Act of Octo-
- 16 ber 17, 1978 (16 U.S.C. 715s), \$13,228,000.
- 17 NORTH AMERICAN WETLANDS CONSERVATION FUND
- 18 For expenses necessary to carry out the provisions
- 19 of the North American Wetlands Conservation Act (16
- 20 U.S.C. 4401 et seq.), \$43,000,000, to remain available
- 21 until expended.
- 22 NEOTROPICAL MIGRATORY BIRD CONSERVATION
- For expenses necessary to carry out the Neotropical
- 24 Migratory Bird Conservation Act (16 U.S.C. 6101 et
- 25 seq.), \$3,910,000, to remain available until expended.

- 2 For expenses necessary to carry out the African Ele-
- 3 phant Conservation Act (16 U.S.C. 4201 et seq.), the
- 4 Asian Elephant Conservation Act of 1997 (16 U.S.C.
- 5 4261 et seq.), the Rhinoceros and Tiger Conservation Act
- 6 of 1994 (16 U.S.C. 5301 et seq.), the Great Ape Con-
- 7 servation Act of 2000 (16 U.S.C. 6301 et seq.), and the
- 8 Marine Turtle Conservation Act of 2004 (16 U.S.C. 6601
- 9 et seq.), \$12,061,000, to remain available until expended.
- 10 STATE AND TRIBAL WILDLIFE GRANTS
- 11 For wildlife conservation grants to States and to the
- 12 District of Columbia, Puerto Rico, Guam, the United
- 13 States Virgin Islands, the Northern Mariana Islands,
- 14 American Samoa, and Indian tribes under the provisions
- 15 of the Fish and Wildlife Act of 1956 and the Fish and
- 16 Wildlife Coordination Act, for the development and imple-
- 17 mentation of programs for the benefit of wildlife and their
- 18 habitat, including species that are not hunted or fished,
- 19 \$65,571,000, to remain available until expended: Pro-
- 20 vided, That of the amount provided herein, \$4,209,000 is
- 21 for a competitive grant program for Indian tribes not sub-
- 22 ject to the remaining provisions of this appropriation: *Pro-*
- 23 vided further, That \$6,362,000 is for a competitive grant

- 11 For expenses necessary to carry out recreation pro-
- 12 grams, natural programs, cultural programs, heritage
- 13 partnership programs, environmental compliance and re-
- 14 view, international park affairs, and grant administration,
- 15 not otherwise provided for, \$64,138,000.
- 16 HISTORIC PRESERVATION FUND
- 17 For expenses necessary in carrying out the National
- 18 Historic Preservation Act (division A of subtitle III of title
- 19 54, United States Code), \$88,910,000, to be derived from
- 20 the Historic Preservation Fund and to remain available
- 21 until September 30, 2020: Provided, That of the funds
- 22 provided for the Historic Preservation Fund, \$500,000 is
- 23 for competitive grants for the survey and nomination of
- 24 properties to the National Register of Historic Places and
- 25 as National Historic Landmarks associated with commu-

- 1 nities currently under-represented, as determined by the
- 2 Secretary, \$13,000,000 is for competitive grants to pre-
- 3 serve the sites and stories of the Civil Rights movement,
- 4 \$5,000,000 is for grants to Historically Black Colleges
- 5 and Universities, and \$5,000,000 is for competitive grants
- 6 for the restoration of historic properties of national, State

- 23 pended: Provided, That notwithstanding any other provi-
- 24 sion of law, for any project initially funded in fiscal year
- 25 2019 with a future phase indicated in the National Park

- 1 Service 5-Year Line Item Construction Plan, a single pro-
- 2 curement may be issued which includes the full scope of
- 3 the project: Provided further, That the solicitation and
- 4 contract shall contain the clause availability of funds
- 5 found at 48 CFR 52.232–18: Provided further, That Na-
- 6 tional Park Service Donations, Park Concessions Fran-
- 7 chise Fees, and Recreation Fees may be made available
- 8 for the cost of adjustments and changes within the origi-
- 9 nal scope of effort for projects funded by the National

- 14 (INCLUDING TRANSFER OF FUNDS)
- In addition to other uses set forth in section
- 16 101917(c)(2) of title 54, United States Code, franchise
- 17 fees credited to a sub-account shall be available for ex-
- 18 penditure by the Secretary, without further appropriation,
- 19 for use at any unit within the National Park System to
- 20 extinguish or reduce liability for Possessory Interest or
- 21 leasehold surrender interest. Such funds may only be used
- 22 for this purpose to the extent that the benefitting unit an-

- 24 ized by 43 U.S.C. 31, 1332, and 1340; classify lands as
- 25 to their mineral and water resources; give engineering su-

- 1 pervision to power permittees and Federal Energy Regu-
- 2 latory Commission licensees; administer the minerals ex-
- 3 ploration program (30 U.S.C. 641); conduct inquiries into
- 4 the economic conditions affecting mining and materials
- 5 processing industries (30 U.S.C. 3, 21a, and 1603; 50
- 6 U.S.C. 98g(1)) and related purposes as authorized by law;
- 7 and to publish and disseminate data relative to the fore-
- 8 going activities; \$1,148,457,000, to remain available until
- 9 September 30, 2020; of which \$84,337,000 shall remain
- 10 available until expended for satellite operations; and of
- 11 which \$15,164,000 shall be available until expended for
- 12 deferred maintenance and capital improvement projects
- 13 that exceed \$100,000 in cost: Provided, That none of the
- 14 funds provided for the ecosystem research activity shall
- 15 be used to conduct new surveys on private property, unless
- 16 specifically authorized in writing by the property owner:
- 17 Provided further, That no part of this appropriation shall
- 18 be used to pay more than one-half the cost of topographic
