A BILL

To amend the Harmonized Tariff Schedule of the United States to clarify the classification of recreational performance outerwear, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-
2 tives of the United States of America in Congress assembled,*

3 **SECTION 1. KNIT APPAREL AND ACCESSORIES.**

4 (a) DEFINITIONS.—The Additional U.S. Note to
5 Chapter 61 of the Harmonized Tariff Schedule of the
6 United States is amended—

7 (1) in the heading, by striking “Additional U.S.
8 Note” and inserting “Additional U.S. Notes”; and

1 (2) by adding at the end the following new
2 notes:

3 “2. (a) For purposes of this chapter, the term ‘rec-
4 reational performance outerwear’ means trousers (includ-
5 ing, but not limited to, paddling pants, ski or snowboard
6 pants, and ski or snowboard pants intended for sale as
7 parts of ski-suits), coveralls and bib overalls, and jackets
8 (including, but not limited to, full zip jackets, paddling
9 jackets, ski jackets, and ski jackets intended for sale as
10 parts of ski-suits), windbreakers, and similar articles (in-
11 cluding padded, sleeveless jackets) composed of knit fab-
12 rics of cotton, wool, hemp, bamboo, silk, or manmade
13 fiber, or a combination of such fibers, that are either
14 water-resistant or visibly coated, or both, with critically
15 sealed seams, and with 5 or more of the following features:

16 “(i) Insulation for cold weather protection.

17 “(ii) Pockets, at least one of which has a
18 zippered, hook and loop, or other type of closure.

19 “(iii) Elastic, drawcord, or other means of
20 tightening around the waist or leg hems, including
21 hidden leg sleeves with a means of tightening at the
22 ankle for trousers and tightening around the waist
23 or bottom hem for jackets.

24 “(iv) Venting, not including grommet(s).

25 “(v) Articulated elbows or knees.

1 “(vi) Reinforcement in one of the following
2 areas: the elbows, shoulders, seat, knees, ankles, or
3 cuffs.

4 “(vii) Weatherproof closure at the waist or
5 front.

6 “(viii) Multi-adjustable hood or adjustable col-
7 lar.

8 “(ix) Adjustable powder skirt, inner protective
9 skirt, or adjustable inner protective cuff at sleeve
10 hem.

11 “(x) Construction at the arm gusset that uti-
12 lizes fabric, design, or patterning to allow radial arm
13 movement.

14 “(xi) Odor control technology.

15 The term ‘recreational performance outerwear’ does not
16 include occupational outerwear or garments with an outer
17 surface of looped pile.

18 “(b) For purposes of this Note, the following terms
19 have the following meanings:

20 “(i) The term ‘water-resistant’ means that a
21 garment must have a water resistance (see ASTM
22 designations D 3779–81 and D 7017) such that,
23 under a head pressure of 600 millimeters, not more
24 than 1.0 gram of water penetrates after two minutes
25 when tested in accordance with the current version

1 of AATCC Test Method 35. The water resistance of
2 the garment is the result of a rubber or plastics ap-
3 plication to the outer shell, lining, or inner lining.

4 “(ii) The term ‘visibly coated’ refers to fabric
5 that is impregnated, coated, covered, or laminated
6 with plastics, such as fabrics described in Note 2 to
7 chapter 59.

8 “(iii) The term ‘sealed seams’ means seams
9 that have been covered by means of taping, gluing,
10 bonding, cementing, fusing, welding, or a similar
11 process so that water cannot pass through the seams
12 when tested in accordance with the current version
13 of AATCC Test Method 35.

14 “(iv) The term ‘critically sealed seams’
15 means—

16 “(A) for jackets, sealed seams that are
17 sealed at the front and back yokes, or at the
18 shoulders, arm holes, or both, where applicable;
19 and

20 “(B) for trousers, sealed seams that are
21 sealed at the front (up to the zipper or other
22 means of closure) and back rise.

23 “(v) The term ‘insulation for cold weather pro-
24 tection’ means insulation with either synthetic fill,

1 down, a laminated thermal backing, or other lining
2 for thermal protection from cold weather.

3 “(vi) The term ‘venting’ refers to closeable or
4 permanent constructed openings in a garment (ex-
5 cluding front, primary zipper closures and grom-
6 met(s)) to allow increased expulsion of built-up heat
7 during outdoor activities. In a jacket, such openings
8 are often positioned on the underarm seam of a gar-
9 ment but may also be placed along other seams in
10 the front or back of a garment. In trousers, such
11 openings are often positioned on the inner or outer
12 leg seams of a garment but may also be placed along
13 other seams in the front or back of a garment.

14 “(vii) The term ‘articulated elbows or knees’ re-
15 fers to the construction of a sleeve (or pant leg) to
16 allow improved mobility at the elbow (or knee)
17 through the use of extra seams, darts, gussets, or
18 other means.

19 “(viii) The term ‘reinforcement’ refers to the
20 use of a double layer of fabric or section(s) of fabric
21 that is abrasion-resistant or otherwise more durable
22 than the face fabric of the garment.

23 “(ix) The term ‘weatherproof closure’ means a
24 closure (including, but not limited to, laminated or
25 coated zippers, storm flaps, or other weatherproof

1 construction) that has been reinforced or engineered
2 in a manner to reduce the penetration or absorption
3 of moisture or air through an opening in the gar-
4 ment.

5 “(x) The term ‘multi-adjustable hood or adjust-
6 able collar’ means a draw cord, adjustment tab, or
7 elastic incorporated into the hood or collar construc-
8 tion to allow volume adjustments around a helmet,
9 the crown of the head, neck, or face.

10 “(xi) The terms ‘adjustable powder skirt’ and
11 ‘inner protective skirt’ refer to a partial lower inner
12 lining with means of tightening around the waist for
13 additional protection from the elements.

14 “(xii) The term ‘arm gusset’ means construc-
15 tion at the arm of a gusset that utilizes an extra
16 fabric piece in the under arm usually diamond- or
17 triangular-shaped, design, or pattern to allow radial
18 arm movement.

19 “(xiii) The term ‘radial arm movement’ refers
20 to unrestricted, 180-degree range of motion for the
21 arm while wearing performance outerwear.

22 “(xiv) The term ‘odor control technology’ means
23 an additive in a fabric or garment capable of adsorb-
24 ing, absorbing, or reacting with human odors, or ef-
25 fective in reducing odor-causing bacteria, including

1 but not limited to activated carbon, silver, copper, or
2 any combination thereof.

3 “(xv) The term ‘occupational outerwear’ means
4 outerwear garments, including uniforms, designed or
5 marketed for use in the workplace or at a worksite
6 to provide durable protection from cold or inclement
7 weather and/or workplace hazards, such as fire, elec-
8 trical, abrasion, or chemical hazards, or impacts,
9 cuts, punctures, or similar hazards.

10 “3. For purposes of this chapter, the importer of
11 record shall certify upon entry whether garments claimed
12 as recreational performance outerwear have an outer sur-
13 face that is water-resistant, visibly coated, or a combina-
14 tion thereof, and shall further enumerate the specific fea-
15 tures that make the garments eligible to be classified as
16 recreational performance outerwear.”.

17 (b) TARIFF CLASSIFICATIONS.—Chapter 61 of the

- 3 “(i) Insulation for cold weather protection.
- 4 “(ii) Pockets, at least one of which has a
5 zippered, hook and loop, or other type of closure.
- 6 “(iii) Elastic, drawcord, or other means of
7 tightening around the waist or leg hems, including
8 hidden leg sleeves with a means of tightening at the
9 ankle for trousers and tightening around the waist
10 or bottom hem for jackets.
- 11 “(iv) Venting, not including grommet(s).
- 12 “(v) Articulated elbows or knees.
- 13 “(vi) Reinforcement in one of the following
14 areas: the elbows, shoulders, seat, knees, ankles, or
15 cuffs.
- 16 “(vii) Weatherproof closure at the waist or
17 front.
- 18 “(viii) Multi-adjustable hood or adjustable col-
19 lar.
- 20 “(ix) Adjustable powder skirt, inner protective
21 skirt, or adjustable inner protective cuff at sleeve
22 hem.
- 23 “(x) Construction at the arm gusset that uti-
24 lizes fabric, design, or patterning to allow radial arm
25 movement.

- 1 “(xi) Odor control technology.
- 2 The term ‘recreational performance outerwear’ does not
- 3 include occupational outerwear.
- 4 “(b) For purposes of this Note, the following terms
- 5 have the following meanings:
- 6 “(i) The term ‘water-resistant’ means that a
- 7 garment must have a water resistance (see ASTM
- 8 designations D 3779–81 and D 7017) such that,
- 9 under a head pressure of 600 millimeters, not more
- 10 than 1.0 gram of water penetrates after two minutes
- 11 when tested in accordance with the current version
- 12 of AATCC Test Method 35. The water resistance of
- 13 the garment is the result of a rubber or plastics ap-
- 14 plication to the outer shell, lining, or inner lining.
- 15 “(ii) The term ‘visibly coated’ refers to fabric
- 16 that is impregnated, coated, covered, or laminated
- 17 with plastics, such as fabrics described in Note 2 to
- 18 chapter 59.
- 19 “(iii) The term ‘sealed seams’ means seams
- 20 that have been covered by means of taping, gluing,
- 21 bonding, cementing, fusing, welding, or a similar
- 22 process so that water cannot pass through the seams
- 23 when tested in accordance with the current version
- 24 of AATCC Test Method 35.

1 “(iv) The term ‘critically sealed seams’ means
2 seams’ that are sealed—

3 “(A) for jackets, at the front and back
4 yokes, or at the shoulders, arm holes, or both,
5 where applicable; and

6 “(B) for trousers, at the front (up to the
7 zipper or other means of closure) and back rise.

8 “(v) The term ‘insulation for cold weather pro-
9 tection’ means insulation with either synthetic fill,
10 down, a laminated thermal backing, or other lining
11 for thermal protection from cold weather.

12 “(vi) The term ‘venting’ refers to closeable or
13 permanent constructed openings in a garment (ex-
14 cluding front, primary zipper closures and grom-
15 met(s)) to allow increased expulsion of built-up heat
16 during outdoor activities. In a jacket, such openings
17 are often positioned on the underarm seam of a gar-
18 ment but may also be placed along other seams in
19 the front or back of a garment. In trousers, such
20 openings are often positioned on the inner or outer
21 leg seams of a garment but may also be placed along
22 other seams in the front or back of a garment.

23 “(vii) The term ‘articulated elbows or knees’ re-
24 fers to the construction of a sleeve (or pant leg) to
25 allow improved mobility at the elbow (or knee)

1 through the use of extra seams, darts, gussets, or
2 other means.

3 “(viii) The term ‘reinforcement’ refers to the
4 use of a double layer of fabric or section(s) of fabric
5 that is abrasion-resistant or otherwise more durable
6 than the face fabric of the garment.

7 “(ix) The term ‘weatherproof closure’ means a
8 closure (including, but not limited to, laminated or
9 coated zippers, storm flaps, or other weatherproof
10 construction) that has been reinforced or engineered
11 in a manner to reduce the penetration or absorption
12 of moisture or air through an opening in the gar-
13 ment.

14 “(x) The term ‘multi-adjustable hood or adjust-
15 able collar’ means a draw cord, adjustment tab, or
16 elastic incorporated into the hood or collar construc-
17 tion to allow volume adjustments around a helmet,
18 the crown of the head, neck, or face.

19 “(xi) The terms ‘adjustable powder skirt’ and
20 ‘inner protective skirt’ refer to a partial lower inner
21 lining with means of tightening around the waist for
22 additional protection from the elements.

23 “(xii) The term ‘arm gusset’ means construc-
24 tion at the arm of a gusset that utilizes an extra
25 fabric piece in the under arm usually diamond- or

1 triangular-shaped, design, or pattern to allow radial
2 arm movement.

3 “(xiii) The term ‘radial arm movement’ refers
4 to unrestricted, 180-degree range of motion for the
5 arm while wearing performance outerwear.

6 “(xiv) The term ‘odor control technology’ means
7 an additive in a fabric or garment capable of adsorb-
8 ing, absorbing, or reacting with human odors, or ef-
9 fective in reducing odor-causing bacteria, including
10 but not limited to activated carbon, silver, copper, or
11 any combination thereof.

12 “(xv) The term ‘occupational outerwear’ means
13 outerwear garments, including uniforms, designed or
14 marketed for use in the workplace or at a worksite
15 to provide durable protection from cold or inclement
16 weather and/or workplace hazards, such as fire, elec-
17 trical, abrasion, or chemical hazards, or impacts,
18 cuts, punctures, or similar hazards.

7 **SEC. 3. RULE OF CONSTRUCTION WITH RESPECT TO PRESI-**
