A BILL

To modify the boundary of the Wilson’s Creek National Battlefield in the State of Missouri, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Wilson’s Creek Na-
5 tional Battlefield Boundary Revision Act of 2021”.

1 **SEC. 2. WILSON'S CREEK NATIONAL BATTLEFIELD BOUND-**
 2 **ARY MODIFICATION.**

3 Section 1(b) Public Law 86-434 (16 U.S.C.
 4 430kk(b)) is amended—

5 (1) in paragraph (1)—

6 (A) in the second sentence, by striking
 7 “The map” and inserting the following:

8 “(C) AVAILABILITY OF MAPS.—The maps
 9 described in subparagraphs (A) and (B)”;

10 (B) by striking “(1) The boundaries” and
 11 inserting the following:

12 “(1) ADDITIONAL LAND.—

13 “(A) IN GENERAL.—The boundaries”;

14 (C) by inserting after subparagraph (A)
 15 (as so designated) the following:

16 “(B) NEWTONIA BATTLEFIELD ADDI-
 17 TION.—The boundary of the Wilson’s Creek
 18 National Battlefield is revised to include the ap-
 19 proximately ~~624~~ 25 acres of land identified as
 20 ‘Proposed Addition’ on the map entitled ‘Wil-
 21 son’s Creek National Battlefield Proposed
 22 Boundary Modification’, numbered 410/
 23 177,379, and dated ~~September 2021~~ *July*
 24 *2022.*”; and

25 (D) by adding at the end the following:

1 “(D) ERRORS.—The Secretary of the Inte-
2 rior may correct any clerical or typographical
3 error in a map described in subparagraph (A)
4 or (B).”; and

5 (2) in paragraph (2)—

6 (A) by striking “(2) The Secretary is au-
7 thorized to acquire the lands referred to in
8 paragraph (1)” and inserting the following:

9 “(2) METHOD OF ACQUISITION.—The Secretary
10 of the Interior may acquire the land described in
11 subparagraphs (A) and (B) of paragraph (1)”; and

12 (B) in the second sentence, by striking
13 “park” and inserting “Wilson’s Creek National
14 Battlefield”.
