A BILL

To amend the Higher Education Act of 1965 to provide for comprehensive student achievement information.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Comprehensive Stu-
5 dent Achievement Information Act of 2017”.

6 **SEC. 2. CONSUMER INFORMATION ABOUT COMPLETION OR**
7 **GRADUATION TIMES.**

8 (a) **TRANSPARENCY IN COLLEGE TUITION FOR CON-**
9 **SUMERS.**—Section 132(i)(1)(J) of the Higher Education

1 Act of 1965 (20 U.S.C. 1015a(i)(1)(J)) is amended to
2 read as follows:

3 “(J)(i) For programs of study 4 years of
4 length or longer—

5 “(I) the percentages of first-time, full-
6 time, degree- or certificate-seeking under-
7 graduate students enrolled at the institu-
8 tion who obtain a degree or certificate
9 within each of the times for completion or
10 graduation described in subclauses (I)
11 through (III) of clause (ii);

12 “(II) the percentages of first-time,
13 part-time, degree- or certificate-seeking un-
14 dergraduate students enrolled at the insti-
15 tution who obtain a degree or certificate
16 within each of the times for completion or
17 graduation described in subclauses (I)
18 through (III) of clause (ii);

19 “(III) the percentages of non-first
20 time, full-time, degree- or certificate-seek-
21 ing undergraduate students enrolled at the
22 institution who obtain a degree or certifi-
23 cate within each of the times for comple-
24 tion or graduation described in subclauses
25 (I) through (III) of clause (ii); and

1 “(IV) the percentages of non-first-
2 time, part-time, degree- or certificate-seek-
3 ing undergraduate students enrolled at the
4 institution who obtain a degree or certifi-
5 cate within each of the times for comple-
6 tion or graduation described in subclauses
7 (I) through (III) of clause (ii).

8 “(ii) The times for completion or gradua-
9 tion described in clause (i) are—

10 “(I) the normal time for completion
11 of, or graduation from, the student’s pro-
12 gram;

13 “(II) 150 percent of the normal time
14 for completion of, or graduation from, the
15 student’s program; and

16 “(III) 200 percent of the normal time
17 for completion of, or graduation from, the
18 student’s program.

19 “(iii) For programs of study less than 4
20 years—

21 “(I) the percentages of first-time, full-
22 time, degree- or certificate-seeking under-
23 graduate students enrolled at the institu-
24 tion who obtain a degree or certificate
25 within each of the times for completion or

1 graduation described in subclauses (I)
2 through (III) of clause (iv);

3 “(II) the percentages of first-time,
4 part-time, degree- or certificate-seeking un-
5 dergraduate students enrolled at the insti-
6 tution who obtain a degree or certificate
7 within each of the times for completion or
8 graduation described in subclauses (I)
9 through (III) of clause (iv);

10 “(III) the percentages of non-first-
11 time, full-time, degree- or certificate-seek-
12 ing undergraduate students enrolled at the
13 institution who obtain a degree or certifi-
14 cate within each of the times for comple-
15 tion or graduation described in subclauses
16 (I) through (III) of clause (iv); and

17 “(IV) the percentages of non-first-
18 time, part-time, degree- or certificate-seek-
19 ing undergraduate students enrolled at the
20 institution who obtain a degree or certifi-
21 cate within each of the times for comple-
22 tion or graduation described in subclauses
23 (I) through (III) of clause (iv).

24 “(iv) The times for completion or gradua-
25 tion described in clause (iii) are—

1 “(I) the normal time for completion
2 of, or graduation from, the student’s pro-
3 gram;

4 “(II) 150 percent of the normal time
5 for completion of, or graduation from, the
6 student’s program; and

7 “(III) 300 percent of the normal time
8 for completion of, or graduation from, the
9 student’s program.

10 “(v) In making publicly available the per-
11 centages described in this subparagraph, the
12 Secretary shall display each percentage in a
13 consistent manner and with equal visibility.”.

14 (b) INSTITUTIONAL AND FINANCIAL ASSISTANCE IN-
15 FORMATION FOR STUDENTS.—Section 485(a)(1)(L) of the
16 Higher Education Act of 1965 (20 U.S.C. 1092(a)(1)(L))
17 is amended to read as follows:

18 “(L) the completion or gradua-
19 tion rates described in section
20 132(i)(1)(J);”.
