## A BILL

To amend the Small Business Act to require the Small Business and Agriculture Regulatory Enforcement Ombudsman to create a centralized website for compliance guides, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “One Stop Shop for  
5 Small Business Compliance Act of 2022”.

1 **SEC. 2. CENTRALIZED WEBSITE FOR COMPLIANCE GUIDES.**

2 Section 30 of the Small Business Act (15 U.S.C. 657)  
3 is amended by adding at the end the following:

4 “(e) **CENTRALIZED WEBSITE.**—Not later than 6  
5 months after the date of enactment of this subsection, the  
6 Ombudsman shall maintain a publicly available website  
7 that includes—

8 “(1) hyperlinks to small entity compliance  
9 guides described in section 212(a)(1) of the Small  
10 Business Regulatory Enforcement Fairness Act of  
11 1996 (5 U.S.C. 601 note); and

12 “(2) with respect to each small entity compli-  
13 ance guide described in paragraph (1), the contact  
14 information for an individual who can offer assist-  
15 ance to small entities with respect to the rules that  
16 are the subject of the guide.

17 “(f) **REPORT ON AGENCY COMPLIANCE.**—The Om-  
18 budsman shall include in the annual report required under  
19 subsection (b)(2)(C) an assessment of agency compliance  
20 with the requirements of section 212 of the Small Busi-  
21 ness Regulatory Enforcement Fairness Act of 1996 (5  
22 U.S.C. 601 note) for the year covered by the annual re-  
23 port.”.
