## A BILL

To enhance efforts to combat human trafficking in connection with the catching and processing of seafood products imported into the United States, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Facilitate Addressing  
5 Issues with Regulating Forced Labor in International Sea-  
6 food Harvesting Act” or “FAIR FISH Act”.

7 **SEC. 2. FINDING.**

8 Congress finds that human trafficking is a pervasive  
9 problem in the catching and processing of certain seafood

1 products imported into the United States, particularly sea-  
2 food products obtained through illegal, unreported, and  
3 unregulated fishing.

4 **SEC. 3. SECRETARY OF COMMERCE AS MEMBER OF INTER-**  
5 **AGENCY TASK FORCE TO MONITOR AND COM-**  
6 **BAT TRAFFICKING.**

7 Section 105(b) of the Victims of Trafficking and Vio-  
8 lence Protection Act of 2000 (22 U.S.C. 7103(b)) is  
9 amended by inserting “Secretary of Commerce,” after  
10 “Secretary of Education,”.

11 **SEC. 4. REPORT.**

12 Not later than 1 year after the date of enactment  
13 of this Act, the Administrator of the National Oceanic and  
14 Atmospheric Administration and the Commissioner of the  
15 Food and Drug Administration shall jointly submit to  
16 Congress a report on the existence of human trafficking  
17 in the supply chains of seafood products imported into the  
18 United States. The report shall include the following:

19 (1) A list of the countries at risk for human  
20 trafficking in their seafood catching and processing  
21 industries, and an assessment of such risk for each  
22 country listed.

23 (2) A description of the quantity and economic  
24 value of seafood products imported into the United

1 States from the countries listed pursuant to para-  
2 graph (1).

3 (3) A description and assessment of the meth-  
4 ods, if any, in the countries listed pursuant to para-  
5 graph (2) to trace and account for the manner in  
6 which seafood is caught.

7 (4) A description of domestic and international  
8 enforcement mechanisms to deter illegal practices in  
9 the catching of seafood in the countries listed pursu-  
10 ant to paragraph (1).

11 (5) Such recommendations as the Administrator  
12 and the Commissioner jointly consider appropriate  
13 for legislative or administrative action to enhance  
14 and improve actions against human trafficking in  
15 the catching and processing of seafood products  
16 abroad.
